It is currently undertaking a major campaign to promote "ni2012" - a series of key events and anniversaries including the opening of new visitor facilities at Titanic Belfast and the Giant's Causeway - worldwide.
- Tourism Ireland actively promotes Northern Ireland as the home of Golf and will build on its activity in light of the recent success of Northern Irish Golfers such as Rory McIlroy, Darren Clarke and Graeme McDowell and the hosting of the 2012 Irish Open Championship at Royal Portrush.

#### Invest NI will:

# Key Objectives for 2012-13

- DEL will support the universities through a dedicated European Framework Support Fund to encourage greater participation in FP7 and their involvement of local companies in applications.
- Commission DEL/DETI scoping study of University capacity to increase FP7 (Horizon 2020) participation and identify barriers/opportunities for improvement
- DARD will promote and enhance effective technology and technology transfer arrangements in the agri-food sector.

- Number of successful applications made by HSC Trusts

- Evidence of re-balancing in favour of private sector and / or EU income across the Northern Ireland Clinical Research Network

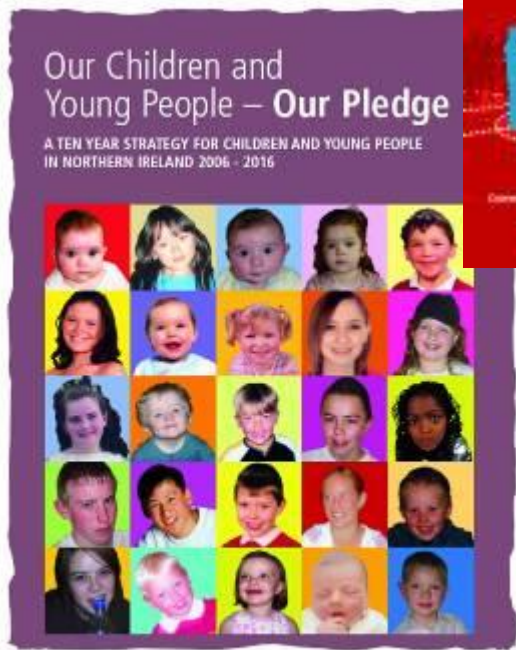

# Key Facts

- 1.8 million population
- Some 110,000 children in poverty
- Youth unemployment has risen to about 30% during the recession
- Of 16 to 21 year olds: between 25% and 33% have no qualifications
- Incomes of the top 20% of households around 4.1 times greater than those of the bottom 20% compared to 3.8 in 2002/03
- More peace walls now than before cease fires
- 64% report that all or most of their friends are of the same religion
- High levels of fuel poverty

- DCAL has 5 strategic pillars – Economy, Education, Health, Environment and Social Inclusion.
- We will continue to harness the potential of the culture, arts and leisure sectors to enhance and transform the lives of people and communities.
- We will enable the population to enhance their quality of life through participation/engagement in culture, arts and leisure activities
- The DCAL Minister is particularly interested in developing projects which target our most deprived communities and issues which are related to our recent troubled past, such as a low educational and skills base and high rates of suicide in young men.



# Key Objectives for 2012-13

## Arts

- Arts Council direct a significant proportion of their grants to organisations operating in our most deprived communities, bringing divided communities together and improving health and education.
- Arts Council and their partner organisations have previously availed of EU Funds to help bring international perspectives to local social cohesion issues such as reimaging gable wall images, research into art and culture in prison and cross border cultural policies and their effect on local communities.
- Arts Council will continue to seek opportunities for EU competitive funds under the EU Culture Programme, with a view to building on the success of the Belfast Festival at Queens who were awarded €300k under the Culture Fund Festivals strand in 2011.



# Key Objectives for 2012-13

## Sport

- The Sport Matters Community Capital Programme aims to provide facilities in areas where they are currently lacking. The facilities will provide sports and cultural activities and will increase participation in sport by those who have not participated in the past. An important aspect of the scheme is that facilities developed as a result of awards from this fund should be open to all sections of the community for the encouragement of the wide variety of sports.
- DCAL and Sport Ni will continue to seek opportunities to deliver projects which help people develop healthy lifestyles.
- DCAL's Sport Matters Policy is aligned with the EU Sports policy Developing the European Dimension in Sport and DCAL will be aiding Sport Ni and partners to access funding for Sports projects from 2014 onwards under the proposed education, training, youth and sport programme 'Erasmus for All'.
