# <u>IDENTIFICATION OF SAVINGS FROM PRACTICAL CO-OPERATION WITH THE</u> ROI IN THE OPERATIONAL DELIVERY OF PUBLIC SERVICES

As part of the ongoing programme of work to identify potential efficiencies, the Budget Review Group had asked for some information as regards the possible level of savings from practical co-operation in the operational delivery of services between NI and the RoI, within existing structures.

In response, NI departments were asked to provide details of the current position in respect of:

- (a) Ongoing areas of practical co-operation with the Rol to deliver savings, including the level of savings actually achieved; and
- (b) Additional costs imposed by proximity to the Rol.

In providing this information, departments were informed that this exercise excluded the ongoing activities of North-South bodies. All departments have now provided returns as summarised in Appendix A. In particular, Table A1 shows that savings of £0.3 million were achieved in 2011-12 from practical co-operation with the RoI in the delivery of public services while Table A2 shows that there was an additional cost to the provision of public services in NI of £11.6 million in the same financial year, mainly due to RoI residents using NI public services.
