ANNEX A

The number of individuals taking part in employment programmes funded by the Department is set out below. Only the information relating to Steps to Success, European Social Fund and Neighbourhood Renewal is available at constituency level. The remaining data is broken down by council area.

JobStart Scheme - 2 April 2021 to 31 May 2022

This Scheme provides employment opportunities for young people aged 16-24 who are at risk of long term unemployment. At 31 May 2022, 1,427 young people had started the Scheme. (Please see table at Annex 1)

Steps 2 Success (S2S) - October 2017 to March 2021The aim of S2S was to help eligible benefit recipients find and sustain work thereby supporting the needs of employers and the economy. By March 2021, 22,481 people had participated in S2S. (Please see table at Annex 2).

Work Ready Employment Service (WRES) - 13 April 2021 to 17 May 2022

WRES offers short, modular-based employability training for all 'work-ready' customers who have made a claim to a relevant benefit. At 31 May 2022, 1,827 customers had been referred to at least one module. (Please see table at Annex 3).

Adviser Discretion Fund (ADF) - 1 April 2017 to 31 March 2022

ADF provides financial support in the form of grant payments to eligible customers to purchase essential goods or services to remove a barrier to employment. From 1 April 2017 to 31 March 2022, out of 1327 ADF applications 1,308 awards have been made for training purposes. (Please see table at Annex 4, this information is not held at constituency or council level).

Were provided quality work experience placements to participants who are job ready. The Opportunity Guarantee strand of the programme provided opportunities which must be linked to the guarantee of an interview for either a job or apprenticeship. From 1 April 2017 to 31 March 2022, 325 people have participated in the Work Experience Programme (including Opportunity Guarantee). (Please see table at Annex 5, this information

European Social Fund (ESF) – Match Funding

is not held at constituency or council level).

DfC provided public match funding to 18 projects in ESF Call 2 (2018 to 2022). These projects aim to raise employment levels amongst people with disabilities and assist participants into the labour market thus contributing to a strong, growing and sustainable economy in Northern Ireland. Over the 5 year period 2017 to 2022 12,009 people enrolled on these projects. (Please see table at Annex 6).

TBUC Young Leaders Training & Ambassadors Programme

This programme targets young people aged between 16 and 24 years, challenging them through a training package to become the next generation of community leaders. (Please see table at Annex 7).

Neighbourhood Renewal

Under the People & Place Strategy opportunities are provided for people who previously disengaged from full time education and/or are economically inactive, to gain accredited qualifications enabling people to find employment. (Please see table at Annex 8).
