# Northern Ireland Qualifications per Constituency Area

#### **1** Introduction

RaISe has prepared this briefing note in response to an MLA query regarding:

• The geographical spread across Northern Ireland of graduates working in the local labour markets.

• The geographical spread across Northern Ireland of those working in the local labour market with vocational skills, and those without basic skills.

The note presents data from the Labour Force Survey (LFS) 2018 and Census 2011. It shows the geographical spread of the Northern Ireland (NI) workforce according to (i) highest qualification gained; and (ii) all persons with no qualifications, per constituency area.

## 2 Labour Force Survey 2018 and Census 2011 Students & Qualifications.

RalSe approached DfE and NISRA for relevant information for this query and NISRA provided data from the LFS 2018, for parliamentary constituencies. The data is not available for smaller geographies <sup>1</sup>.

#### **Definitions.**

#### Qualified to Level 1+

Persons qualified to Level 1 and above include those listed at Level 2+, Level 3+, Level 4+ AND persons with fewer than 5 GCSE's, BTEC first/General Diploma, NVQ Level 1 or equivalent or Basic Skills Qualifications.

#### Qualified to Level 2+

Persons qualified to Level 2 and above include those listed at Level 3+ AND Level 4+ AND persons with NVQ Level 2 or equivalent, one A Level, AS Levels, 5 or more GCSE's.

<sup>&</sup>lt;sup>1</sup> **The Labour Force Survey** (LFS) is a quarterly sample survey carried out by interviewing people about their personal circumstances and work. It is the biggest regular household survey in Northern Ireland with a typical sample size of c.2,700. The provides a rich and vital source of information about the labour force using internationally agreed concepts and definitions.

#### Qualified to Level 3+

Persons qualified to Level 3 and above include those listed at Level 4+ AND persons with NVQ Level 3, more than one A Level, Baccalaureate (Scottish, International) or Trade Apprenticeships.

#### Qualified to Level 4+

Persons qualified to Level 4 and above include Higher Degrees, First/Foundation Degrees, Diplomas Levels 4 through 8, Nursing Degrees, Teaching Degrees or NVQ Level 4+.

Numbers for those with no qualifications have been suppressed as they are too small for publication.

#### 2.2 Census 2011: Qualifications and Students: No Qualifications

Due to numbers being suppressed under the Labour Force Survey 2018, data has been provided from the Census 2011, which includes all persons aged 16-74, with no qualifications at that time. This includes persons who are economically active and those who are inactive per constituency area.





### Map 2. Northern Ireland workforce in employment, qualified to level 2 and above (aged 16+)


