#### 2. Chairperson's Business

#### 5. Departmental Oral Evidence Session: Programme for Government

**Agreed:** The Committee agreed to write to the Department to request an update on the progress of the Future Agricultural Policy and the Future Rural Policy, in addition to a timeline for the publication of the Ammonia Strategy.

**Agreed:** The Committee agreed to write to the Department to request details on the role of the Independent Environmental Protection Agency, as committed to in the NDNA.

**Agreed:** The Committee agreed to write to the Department to request an analysis of the recent discussion document on the Circular Economy Package/Waste Measures, to include a breakdown by council area.

**Agreed:** The Committee agreed to write to the Department to ask that it liaises with the Department for Infrastructure to provide details of the evidence gathered in relation to PFG Indicator 25 on the percentage of journeys made by walking/cycling/public transport.

6. Departmental Written Briefing: SR 2021/44 – The Zoonoses (Amendment) Order (Northern Ireland) 2021



The Committee considered SR 2021/44: The Zoonoses (Amendment) Order (Northern Ireland) 2021 which will make Severe Acute Respiratory Syndrome Coronavirus 2 (SARSCoV-2), the virus that causes COVID-19, notifiable when it is detected in animals and ensures that the Department can take appropriate control measures if required to protect human health.

**Agreed:** The Committee agreed to inform all witnesses who provided evidence to the Committee on the review that the letter to the Minister will be placed on the Committee's webpage.

The Committee further agreed to write to the Department for Education to ask if a rural needs impact assessment has been completed prior to the decision being made to close the school.

**Agreed:** The Committee agreed to write to the Department to request an update on the progress of the 15 Common Frameworks it is responsible for as well as an indication of when they are expected to be cleared by the Executive.
