13:45 - Kieran Ellison UNITE Regional Officer, emailed Richard Cromie (Head of HR and OD – MEABC) to make him aware that "it has been brought to my attention via a Senior Officer in Unite that staff whose job it is to carry out the Brexit NI protocol appear to have been threatened via graffiti and potentially other methods for carrying out their role."

16:37 - A response email was received confirming that council was aware and that it would be discussed at the full council meeting.

16:41 – Kieran requested Joint Trade Union Side (JTUS) be kept updated

It was brought to our attention that Council had made contact with PSNI at 3pm and were advised that no threat existed. In a meeting with the Mayor on 26 February advised that Group Party Leaders met around 3pm to consider these matters. None of this information was conveyed to JTUS by council and the first we were aware of the withdrawal of staff was when the Mayor's statement to council was played on the BBC late evening news.

Despite our endeavours we have been unable to ascertain who the reported threats arose from or indeed why the police assessment of no threat was ignored.

The Mayor of MEABC read out the following statement at the Council meeting on 1 February confirming the withdrawal of staff:

"Mid and East Antrim Borough Council is immediately withdrawing its staff from inspection duties at Larne Port over concerns for their safety and welfare concerns for their safety and welfare. It follows an upsurge in sinister and menacing behaviour in recent weeks including the appearance of graffiti in the local area referencing increasing tensions around the Northern Ireland protocol and describing port staff as targets and it being 'time for war'.

"Trade unions on behalf of council members of staff assisting with the checks at the port have raised serious concerns around increasing suspicious activity such as apparent information gathering, including the taking of personal registration plates from their vehicles.

"This has caused extreme distress and worry to our staff and we have no option but to withdraw them from their duties in order to fulfill our duty of care and carry out a full risk assessment with the PSNI, Food Standards Agency and DAERA. Tonight I will be writing to Minister [Edwin] Poots to let him know of this decision and we apologise for any disruption that this may cause. Council will provide further updates on the situation when it is appropriate to do so."

Trade Union Side – have made it abundantly clear that the remarks attributed to us are inaccurate and must be withdrawn.
