We recognise that the alcohol sub-categories outlined in Clause 8 account for beer, cider and spirits; wine is not mentioned. We can deduce that wine is excluded on the basis that it is not commonly produced in Northern Ireland.

While the Bill outlines progressive steps to allow small producers to sell their product, it is apparent that the same support is not offered to small importers whose objectives would reinforce the positive impacts mentioned above. For this reason, we do not find the regulatory framework to be sufficiently robust.

The alcohol licensing laws in Great Britain permit the retail of alcohol if the individual/organisation holds a personal licence in conjunction with a premises licence, both of which are subject to certain pre-requisites including personal details, licensing qualifications, planning certificates, building standards certificates, appointed supervisor details (DPS), and operating plans.

Similarly, the alcohol licensing laws in the Republic of Ireland permit the retail of alcohol if the individual/organisation obtains an excise licence, which are further sub-divided into several singular licences for each alcohol product/service (wine retailer's off licence; wine retailer's on licence; beer retailer's off licence; spirit retailer's off licence). The licences may be held either singly or in combination, and the cost of each licence is €500; the licensing period runs from 1 October to 30 September each year regardless of the date of issue.

Contrastingly, the alcohol licensing laws permitting the retail of alcohol in Northern Ireland are severely limitative and unique. We have consulted with legal professionals, economic development officers, and business advisors who have supplied us with the discouraging reality; we must obtain a liquor licence to retail wine in Northern Ireland, a daunting and expensive process that is I kely to cost upward of £80,000.

We aspire to import and retail a select portfolio of wines from a limited number of small producers based in EU countries. Our ambition to do so is built upon our extensive experience within the industry, both in hospitality employs and by self-willed endeavours; we have dedicated years to collating a professional portfolio of producers and wines that place value on sustainable agriculture and healthy lifestyle choices.

Further, we can confirm that the retailing of luxury alcohol is a growing, modern trend in the rest of the UK, Ireland and Europe. The artisanal, small-scale production methods demand significantly higher cost prices than the mainstream brands, which result in premium price brackets; an unsustainable choice for binge consumption and a deterring factor for unmonitored, underage sales.
