We believe while the provisions are positive, they do not go far enough for event organisers or small producers. Anything that can improve current legislation has to be welcomed and allow us to offer what other countries offer and more. Northern Ireland's food and drink tourism offering is still in its infancy stage and can only grow.

At present the bill allows for the department to grant special licences for major events, however no provision has been made for the organisers of other events to apply for occasional licences for both the sale of alcohol for consumption for either on or off site. An occasional licence is not expensive, however currently an applicant must already be a licensee to apply. This practice allows a licensee to seek additional fees for the application which results in increased costs and can force organisers to either abandon or curtail the event.

We believe there should be a mechanism to allow event organisers to apply for occasional licences independent from using another licensee.

We welcome the support for local producers, however we believe the provisions still fall short of what is required to allow small producers to grow.

Firstly clarification is needed regarding the ability for small local producers to sell online.

Secondly no provision has been included to allow for consumption on site, the ability for local producers to be able to sell for consumption on site can only increase the tourism offering. All over the world local breweries have the ability to sell for consumption on site an offering more commonly known as Tap Rooms. These tap rooms increase tourism and increase employment, they do not compete with other bars. In Northern Ireland very few premises offer local produce on tap due to the anti competitive nature of major breweries or cartels entering agreements ensuring only their produce can be sold on tap.

We now have the chance to open the market to allow small producers to grow their sales by volume by legislating for one or more of the following options .

Option 1: Allowing the application of new licences by abolishing the surrender principle thus allowing producers to obtain an Alcohol Licence under current legislation.

Option 2: Creating a provision within the Producers Licence to allow for sale of alcohol for consumption on site.

Option 3: Introducing an amendment forcing licensed premises to sell beers from multiple breweries on tap. This government should no longer sit back and allow this anti competitive behaviour to continue.
