### **5. Matters arising**

The Committee moved to agenda item 4.

The Committee noted a response from the Department regarding concerns raised by the PSNI on the Waste Management Licensing (Amendment) Regulations (Northern Ireland) 2016.

*Mr Boylan rejoined the meeting at 11.08am.*

*Agreed: The Committee agreed to write to the Department requesting an update from officials on its discussions with PSNI in relation to exemptions.*

*Agreed: The Committee agreed to write to representatives from the industry it previously met with to seek their views on the proposed legislation.*

The Committee noted a response from the Department in relation to four proposals for an EU Directives relating to waste.

*Agreed: The Committee agreed to ask to the Department to keep a watching brief on this matter; and to keep the incoming Committee informed on subsidiarity issues arising from EU Directives.*

The Committee noted a copy of the Department's Taxi Driver Communication Bulletin.

The Committee noted a copy of the Department's response to the Committee for Regional Development's request for information on schemes to alleviate flooding and stormwater.

*Agreed: The Committee agreed to write to the Department to ask for information on mechanisms/schemes which provide assistance for built heritage/listed buildings from the impact of flooding.*

The Committee noted a response from Newry, Mourne and Down District Council providing statistics on Japanese Knotweed.

## **6. The Scrap Metal Dealers Bill – Formal Clause by Clause consideration.**

The Committee commenced its formal clause by clause consideration of the Scrap Metal Dealers Bill.

*Agreed: The Committee agreed that at its meeting on Tuesday 9 February 2016 it had reached a consensus that the Committee had run out of time to give proper consideration to all of the issues that had been raised on the Bill; including the amendments proposed by the Department, which impact on every clause other than Clause 21 (short title).*

*Agreed: The Committee agreed that the remaining time left in the Committee Stage would not be sufficient to resolve any outstanding issues.*

### **Clauses 1 to 20.**

*Agreed: The Committee agreed that it would group clauses 1 to 20 in the Scrap Metal Dealers Bill for the formal question.*

“Question: That the Committee is not content to form a view of Clauses 1 to 20, as the Committee is unable to give proper consideration and scrutiny of the complex issues raised at Committee Stage within the time remaining, including that it does not have a full understanding of the impact that the Bill will have on the scrap metal industry, put and agreed to.”
