# 9. SR 2019/193 The Mental Capacity (Research) Regulations (Northern Ireland) 2019

The Committee had considered SR 2019/193 The Mental Capacity (Research) Regulations (Northern Ireland) 2019 at its meeting on 23 January 2020, and agreed that it had no objection to the Rule, subject to the Examiner of Statutory Rules' report.

The Committee noted the Examiner of Statutory Rules had raised an issue with the Regulations and that the Department of Health has laid substitute regulations to address the issue raised.

# 10. SR 2020/17 The Mental Capacity (Research) (Amendment) Regulations (Northern Ireland) 2020

The Committee considered SR 2020/17 The Mental Capacity (Research) (Amendment) Regulations (Northern Ireland) 2020 which have been laid to substitute SR 2019/193. The Mental Capacity (Research) Regulations (Northern Ireland) 2019 and provide a specific list of those who can act as appropriate bodies for the purpose of approving research under the Mental Capacity Act 2016.

- *Agreed:* The Committee agreed to seek further information from the Department Health and defer consideration of the Statutory Rule.
- *Agreed:* The Committee agreed to seek further information regarding the implications of a deprivation of liberty case considered by the Supreme Court, concerning a child: In the matter of D (A Child) [2019] UKSC 42.

## 11. SR 2019/62 Health and Personal Social Services (Superannuation) and Health and Social Care Pension Scheme (Amendment) Regulations 2019

The Committee considered SR 2019/62 Health and Personal Social Services (Superannuation) and Health and Social Care Pension Scheme (Amendment) Regulations 2019 which introduced a 6.25 percentage point increase in employer contributions to 22.5% and provided for existing member contribution rates to continue.

Agreed:	The Committee considered SR 2019/62 Health and Personal Social Services (Superannuation) and Health and Social Care Pension Scheme (Amendment) Regulations, and had no objection to the Rule.
Agreed:	The Committee agreed to request that the Department of Health ask the Scheme Advisory Board to look at the issues the Committee previously raised in relation to the impact of current policies on part-time workers.
Agreed:	The Committee agreed that it would scrutinise pension policy going forward.

## 12. SR 2017/200 The Healthy Start Scheme and Day Care Food Scheme (Amendment) Regulations (Northern Ireland) 2017

The Committee considered SR 2017/200 The Healthy Start Scheme and Day Care Food Scheme (Amendment) Regulations (Northern Ireland) 2017 which amend principal regulations to add Universal Credit to the Healthy Start Scheme's qualifying criteria.

# 13. SR 2019/42 The Provision of Health Services to Persons Not Ordinarily Resident (Amendment) Regulations (Northern Ireland) 2019

The Committee considered SR 2019/42 The Provision of Health Services to Persons Not Ordinarily Resident (Amendment) Regulations (Northern Ireland) 2019 which were created to provide for continuing healthcare provision in respect of certain categories of person, should the UK exit the EU without an agreement.

The Committee considered further information provided by the Department of Health in relation to the Statutory Rule.

A number of Members expressed concern in relation to this Statutory Rule.
