5. Northern Ireland Audit Office (NIAO) – Annual Report and Accounts.

The Committee considered the NIAO Annual Report and Accounts for year ended 31 March 2016, the associated External Audit Findings and a paper from the NIAO in relation to the June Monitoring Round.

Agreed: that scoping work is undertaken on each potential topic to further inform members' consideration at a strategic planning meeting early in the next session.

Agreed: that the Committee will wish to scrutinise the basis for the NIPSO bid for additional resources in the June Monitoring Round, which had been unsuccessful. It was further agreed that, to inform this scrutiny, the Committee will write to the Department of Finance seeking further information on the consideration given to the

- NIPSO bid and clarification on whether there will be an opportunity for NIPSO to resubmit the bid in the next Monitoring Round.

- 7.3 Correspondence dated 23 June 2016 from the Committee for Finance regarding the proposed Memorandum of Understanding on the Budget process.
