- 2. Minutes of previous meeting

- 4.4 Members **noted** that the Final Stage of the Justice Bill (NIA Bill 37/11-15) was no longer scheduled for Monday 29 June.
- 4.5 Members **noted** that the following additional Executive Business was scheduled for Tuesday 30 June:
 - First Stage of the Justice (No.2) Bill, subject to Speaker's clearance;
 - First Stage of the Houses in Multiple Occupation Bill, subject to Speaker's clearance;
 - First Stage of the Housing (Amendment) Bill, subject to Speaker's clearance;
 - Final Stage of the Justice Bill.
