## Correspondence from OFMDFM

Chairpersons were advised of correspondence from the Office of the First Minister and deputy First Minister indicating that it was content with the draft guidance on timescales
for interaction between Assembly committees and departments. The guidance had previously been agreed by CLG at its meeting of 27 January 2015.

## Mobile Phone Connectivity

Chairpersons were advised that the issue of interference on Assembly landline telephones had been resolved. Members were also advised that further updates will be provided in due course on discussions with the mobile network provider in relation to lack of coverage.
