1. Apologies

2. Briefing by Tony O'Reilly: Rights of Persons with Disabilities

Tony O'Reilly, a Committee Member of the North West Forum of People with Disabilities, joined the meeting via StarLeaf at 2:07p.m.

Tony said that people with disabilities in Northern Ireland are viewed as people with special needs; not as human beings within a rights context. Tony noted that in October 2020 Scotland announced plans to remove the Personal Independence Payment (PIP) and a move to place greater emphasis on the principle of human dignity. He stated that the rights of people with disabilities had been ignored for too long. Tony commented that a bill of rights is needed immediately, and that the rights of disabled people should be included within such a bill of rights.

The oral evidence was followed by a question and answer session.

The Chairperson thanked Tony O'Reilly for his evidence.

The briefing session was reported by Hansard.

3. Briefing by Alexa Moore: Perspective on a Bill of Rights

Alexa Moore, Director of TransgenderNI, joined the meeting via StarLeaf at 3:00 p.m.

Alexa said that she supported a bill of rights, commenting that it could address gaps in equality legislation and build towards a better society for everyone. Alexa stated that young people from the LGBTQ community are leaving Northern Ireland as their rights are not upheld and that some communities need to be specifically named in a bill of rights.

She said that while a bill of rights would not be a cure-all, it would provide a framework for the Executive to progress legislation and policy from a rights-based approach and convince young people that it is a new approach for a new decade.

The oral evidence was followed by a question and answer session.

The Chairperson thanked Alexa Moore for her evidence.

The briefing session was reported by Hansard.
