# 1. Apologies

#### 2. Briefing by the Equality Commission for Northern Ireland: Rights and Equality

Ms Geraldine McGahey OBE, Chief Commissioner of the Equality Commission for Northern Ireland (ECNI), Dr Evelyn Collins CBE, Chief Executive of the ECNI, and Ms Roisin Mallon, Director of the ECNI, joined the meeting via StarLeaf at 2:06pm.

Their briefing provided background to the Equality Commission's work, highlighting that it supports the adoption of a strong and inclusive bill of rights, reflecting the particular circumstances of Northern Ireland.

There were discussions around the principle of equality and the impact of Brexit, including the loss of the EU Charter of Fundamental Rights and the limitations of Article 2 of the Protocol on Ireland/Northern Ireland. There were also wide-ranging discussions on how a bill of rights would sit alongside any single equality legislation.

The oral evidence was followed by a question and answer session.

The Chairperson thanked Ms Geraldine McGahey, Dr Evelyn Collins and Ms Roisin Mallon for their evidence.

The briefing session was reported by Hansard.

# 3. Briefing by the Women's Policy Group: Women's Rights

Ms Rachel Powell, Sector Lobbyist, Women's Resource and Development Agency, and Ms Louise Coyle, Director, Northern Ireland Rural Women's Network, joined the meeting via StarLeaf at 2:41pm.

Their briefing provided background to the work of the Women's Policy Group, highlighting that a bill of rights has the potential to build confidence within communities and provide stability in light of Brexit, austerity and COVID-19.

There were discussions on how the COVID-19 pandemic has had a disproportionate impact on women, the lack of paid childcare provision in Northern Ireland and their recommendations on what should be included in a bill of rights. There were also wide-ranging discussions on gender-budgeting.

The oral evidence was followed by a question and answer session.

# 4. Briefing by the Irish Congress of Trade Unions: Perspective on a Bill of Rights

Ms Patricia McKeown, Northern Ireland Committee, Irish Congress of Trade Unions (ICTU), Ms Clare Moore, Equality Officer, ICTU, and Mr John Patrick Clayton, Northern Ireland Committee, ICTU, joined the meeting via StarLeaf at 3:50pm.

Their briefing provided background to the work of the Irish Congress of Trade Unions, highlighting their support for the full implementation of the Belfast/Good Friday Agreement, including a bill of rights.

There were discussions on the protection of workers' rights, especially in the context of Brexit and the new Gender Pay Transparency Directive.

The oral evidence was followed by a question and answer session.
