#### **2. Briefing by the Kevin Hanratty, Director of the Human Rights Consortium and Christopher McCrudden, Professor of Human Rights and Equality Law at Queen's University, Belfast**

Kevin Hanratty, Director of the Human Rights Consortium and Chris McCrudden, Professor of Human Rights and Equality Law at Queen's University, Belfast, joined the meeting via StarLeaf at 2.08 p.m.

Their briefing provided an overview of the five models identified in the report, *Economic and Social Rights in Northern Ireland: Models of Enforceability*, which the Human Rights Centre at Queen's University was commissioned to produce by the Human Rights Consortium. The purpose of these models is to stimulate debate about how economic and social rights can be better delivered. The models span the middle of the spectrum between full enforceability and declaratory principles. They are: i) pre-legislative scrutiny; ii) a piecemeal approach that includes socio-economic requirements in specific legislation; iii) fundamental non-justiciable constitutional duties; iv) progressive implementation with light-touch judicial review; and, v) trade conditionality.

Regarding future involvement, Christopher McCrudden told the Committee that he would be happy to respond with research if it has any further questions.
