The meeting commenced in open session at 2.03 p.m.

1. Apologies

None.

The meeting commenced was suspended at 2.04 p.m. to deal with technical difficulties.

The meeting resumed at 2.11 p.m.

2. Briefing by the Right Honourable Sir Declan Morgan, Lord Chief Justice of Northern Ireland

Sir Declan Morgan, the Lord Chief Justice, and Mandy Kilpatrick, his Principal Private Secretary, joined the meeting via StarLeaf at 2.04 p.m.

Sir Declan's briefing outlined the history of the Bill of Rights concept before examining the justiciability of economic, social and cultural rights. He also considered some international examples. Regarding Northern Ireland, Sir Declan highlighted the example of the Child Poverty Act 2010 which was the subject of litigation in 2012. Sir Declan advised the Committee that for justiciable rights there needs to be sufficient granularity. The courts will also consider if it is a political rather than a legal issue. He suggested this should inform the Committee's judgment about what it wants to do; what a Bill of Rights for Northern Ireland would seek to achieve; and, how the legislature wants to see that held to account, either politically or through the courts.

Christopher Stalford joined the meeting at 2:10p.m.

Michelle McIlveen joined the meeting at 2:17p.m.

The oral evidence was followed by a question and answer session.

The Chairperson thanked the Lord Chief Justice and Mandy for their evidence and apologised for the technical difficulties.

The briefing session was reported by Hansard.
