The meeting commenced at 10.07 am in closed session.

1. Briefing from Assembly Research and Information Services – Budget 2020-2021

An Assembly Research Officer briefed the Committee on budget scrutiny.

The Committee noted a RaISe briefing paper on Assembly Committees Coordinated Budget Scrutiny.

The meeting moved into public session at 10.32 am.

3. COVID-19 Disease Response – Briefing from the Minister of Health and Chief Medical Officer

The Minister of Health, Mr Robin Swann MLA and the Chief Medical Officer, Dr Michael McBride joined the meeting at 10.32 am.

The Minister provided an update on his Department's response to the COVID-19 pandemic.

The briefing was followed by a question and answer session.

The Minister and Chief Medical Officer agreed to provide the Committee with further information on a number of issues raised during the question and answer session.

The Chairperson thanked the Minister and the Chief Medical Officer and requested they attend the Committee's next meeting to answer questions that Members did not have the opportunity to ask during the limited time in which the Minister was available.

The briefing session was reported by Hansard.

The Committee noted the following correspondence relevant to the briefing session:

- A copy of correspondence from the Minster of Health to the Royal College of Nursing regarding PPE guidance;
- A copy of correspondence from the Minister of Justice to the Minster of Health regarding the UK-wide guidance on the use of PPE; and
- Correspondence from the Association of the British Pharmaceutical Industry on the work that the Association and its members have been carrying out in relation to the COVID-19 pandemic.

The meeting was suspended at 11.56 am.

The meeting resumed at 12.10 am.

4. Budget 2019-2020 and 2020-2021 – Department of Health Briefing

Department of Health officials joined the meeting via telephone conferencing at 12.10 pm.

The officials briefed the Committee on the Department of Health budget.

5. SL1 The Draft Children's Social Care (Coronavirus) Regulations (Northern Ireland) 2020

Department of Health officials joined the meeting via telephone conferencing at 1.11 pm.

Ms Eilís McDaniel, Director of Family and Children's Policy, Department of Health Ms Julie Stephenson, Head of Adoption and Children Bill Team, Department of Health

Ms McDaniel briefed the Committee on the Department of Health's intention to make a Statutory Rule to provide HSC Trusts and independent providers of children's social care services with flexibility to continue to provide essential services to looked after children, children in need and care leavers during the surge period of the coronavirus pandemic.

The Chairperson thanked the officials for their attendance.

Agreed: The Committee agreed to seek the views of relevant stakeholders

on the proposed regulations.

Agreed: The Committee agreed that it was content with the proposal for the

Statutory Rule but would consider the matter in further detail when it had received the information it requested from the departmental

officials and heard the views of relevant stakeholders.

The Committee returned to agenda item 3.

6. Chairperson's Business

The Chairperson highlighted the important messages from GPs, the Safeguarding Board and others, to encourage the public to seek medical help when needed and to make child protection calls when concerned.

The Chairperson advised Members that a one-minute silence to remember workers who have died as a result of COVID-19 or other work-related causes, would take place during International Workers' Memorial Day, on Tuesday, 28 April at 11.00 am.

9. Correspondence

Agreed: The Committee agreed to amend the text of the draft letter to acknowledge the fact that Committee Members held differing views on this issue.

- iv. The Committee noted correspondence from the British Association of Social Workers NI regarding guidance on the use of PPE by social workers.
- v. The Committee noted correspondence received from an individual regarding the Westminster Government's response to the COVID-19 pandemic.
- vi. The Committee noted a number of offers of assistance from individuals and organisations in relation to the COVID-19 response and further noted that this correspondence had been forwarded to the Department of Health.
- vii. The Committee noted the Examiner of Statutory Rules' seventh report of Session 2019 2020.
- viii. The Committee considered correspondence from an individual regarding access to health care support during the COVID-19 crisis for people who are deaf.

Agreed: The Committee agreed to forward the correspondence to the Department of Health for comment.

ix. The Committee considered correspondence from an individual regarding COVID-19 emergency shortages and the wording of a draft response to be issued on the Committee's behalf.

Agreed: The Committee agreed that it was content with the text of the draft response and for it to be issued.

The Committee noted a copy of correspondence from the Committee for Education to the Department of Health requesting further information on the package of childcare measures the Department of Education is delivering in partnership with the Department of Health as a result of the COVID-19 pandemic.
- xi. The Committee considered correspondence from an individual regarding COVID-19.

xii. The Committee considered correspondence from Stratagem requesting information on planned Committee Inquiries.

Agreed: The Committee agreed to advise Stratagem that it had no inquiry plans at present.

xiii. The Committee considered correspondence from Ms Rachel Woods MLA regarding personal assistants and PPE access.

xviii. The Committee considered correspondence from an individual regarding the impact of the closure of parks in the Armagh, Banbridge and Craigavon Council area, on children with autism.

> > confirm it was aware that these parks have since opened and advise of the Committee's ongoing engagement with the Department of Health on the challenges faced by people

with autism as a result of the COVID-19 pandemic.

Agreed: The Committee agreed to provide the individual with

> guidance it had requested from the Department of Health on exercise outdoors for people with autism when this has been

received.

xix. The Committee considered correspondence from a dentist regarding financial payments to dentists which do not account for some individual circumstances. Agreed: The Committee agreed to forward the correspondence to the Department of Health for a response.

xx. The Committee noted correspondence from an individual regarding the financial pressures the COVID-19 pandemic is placing on care homes and noted that a Committee Member had responded to the individual on this issue.

Department of Health on plans relating to the development of a medical school at the Ulster University Magee campus.

Members discussed concerns on a range of difficulties in relation to the management of committee business within the current challenging circumstances and the conduct of Members at meetings.

Agreed: The Committee agreed to request responses from the

Department of Health on issues previously raised by the Committee to assist with its scrutiny of COVID-19 related

matters.
