### 3. Oral Evidence Session: NI Business Brexit Working Group (NIBBWG)

## 4. Departmental Written Briefing: ETS Common Framework: SI Greenhouse Gas Emissions Trading Order

The Committee noted and discussed the departmental written briefing on the ETS Common Framework – SI Greenhouse Gas Emissions Trading Order.

- Write to all ETS participants and stakeholders, including the Brexit and Environment Group to seek comments in advance of the departmental oral evidence session on 17 September 2020; and
- Issue a Tweet to in respect of the actions agreed by the Committee.

### 5. SR 2020/105: The Direct Payments to Farmers (Controls and Checks) (Amendment) Scheme (Northern Ireland) 2020

The Committee considered SR 2020/105: The Direct Payments to Farmers (Controls and Checks) (Amendment) Scheme (Northern Ireland) 2020 which will provide a minor amendment to the rules for the application of EU Regulations 1306/2013 for the integrated administration and control system, rural development measures and cross compliance for claim year 2020 due to the situation caused by Covid-19. It will provide derogations from the requirements and reduces the minimum rate of on-the-spot checks, cross compliance, basic payment scheme and young farmer obligations.

Question put and agreed:

"That the Committee for Agriculture, Environment and Rural Affairs, has considered SR 2020/105: The Direct Payments to Farmers (Controls and Checks) (Amendment) Scheme (Northern Ireland) 2020 and has no objection to the rule."

The Committee agreed to the Minister to request that he copies the Committee into the reply to the UFU on the issues raised in their letter and to advise the UFU of the action the Committee has taken.
