8. SR 2020/94: The Direct Payments to Farmers (Penalty Simplification) Regulations (NI) 2020

The Committee considered SR 2020/94: The Direct Payments to Farmers (Penalty Simplification) Regulations (NI) 2020, which wil remove the conditions relating to the first offence of over declaring on a Single Application and repayment if a subsequent over declaration occurs. Anyone who over declares their land area by no more than 10% will have penalty reduced by 50% from the 2020 scheme year onwards.

Question put and agreed:

That the Committee for Agriculture, Environment and Rural Affairs has considered SR 2020/94: The Direct Payments to Farmers (Penalty Simplification Regulations (NI) 2020 and, subject to the Examiner of Statutory Rules report, has no objection to the rule.

The Committee noted a recent Written Question to the Minister in respect of the financial support for Lough Neagh Fishermen.

Agreed: The Committee agreed to write to the Department to urge

that the financial support is progressed urgently and to

request a written briefing on the issue.

The Committee discussed the recent announcement by the Minister in respect of the removal of the greening requirement.

Agreed: The Committee agreed to write to the Department and

request information on what the greening requirement will be

replaced with.
