The meeting commenced at 9.18 a.m. in closed session

1. Matters arising

Mr Jonathan McMillan, Head of Legal Services joined the meeting by StarLeaf at 9.20 a.m. and briefed the Committee on the Legal Advice it had requested in relation to the publication of an email to a Committee Member from a member of the public.

Agreed: The Committee agreed not to publish the contents of the email on the Committee's webpage.

The Committee discussed correspondence a Committee Member had received from Mid and East Antrim Borough Council.

Agreed: The Committee agreed to seek legal advice on how the issues addressed within the correspondence should be dealt with.

Agreed: The Committee agreed to write to the Department to seek a written briefing on the oil spillage incident which occurred on a County Down beach in April 2021.

Agreed: The Committee agreed to consider agenda item 7 next.

5. Committee consideration of the work plan for the Horse Racing (Amendment) Bill and the Committee Motion to extend Committee Stage

The Committee considered the work plan in respect of the Horse Racing (Amendment) Bill and the Committee Motion to extend Committee Stage.

Agreed: The Committee agreed to extend the Committee Stage of the Horse Racing (Amendment) Bill until the 28 January 2022.



Agreed: The Committee agreed to the drafting of a public notice for a call for evidence to be signed off prior to publication.

Agreed: The Committee agreed the list of stakeholders it will seek written and oral evidence from using the thematic approach identified by RaISe.

Agreed: The Committee agreed the timetable of work in connection with the scrutiny of the Horse Racing (Amendment) Bill 2021.

Agreed: The Committee agreed to publish the PSNI briefing paper on the Committee's webpage.



7. Departmental Written Briefing: The Horse Racing (Amendment) Bill – Delegated Powers Memorandum

Agreed: The Committee noted the Delegated Powers Memorandum for the Horse Racing (Amendment) Bill and agreed to publish it on the Committee's webpage.

8. Departmental Written Briefing: SL1 The Agriculture (Student Fees) (Amendment) Regulations 2021

The Committee considered the departmental written briefing on SL1 The Agriculture (Student Fees) (Amendment) Regulations 2021 which will be laid before the Assembly under the Negative Resolution procedure and come into operation on 1 August 2021. The purpose of the SL1 is to apply an increase to tuition fees paid by full-time eligible students attending courses of higher education at CAFRE.

Agreed: The Committee agreed to write to the Department to seek further information on the potential impact the increase in student fees for EU students will have on the number of EU students who may choose to defer applying to CAFRE colleges.

Agreed: The Committee agreed that it was content with merits of the policy and that it should move to the next legislative stage.

9. Departmental Written Briefing: Statutory Instrument AGS/006 The Common Organisation of the Markets in Agricultural Products (Fruit and Vegetable Producer Organisations, Tariff Quotas and Wine) (Amendment etc.) Regulations 2021

The Committee considered the departmental written briefing on the Statutory Instrument AGS/006 The Common Organisation of the Markets in Agricultural Products (Fruit and Vegetable Producer Organisations, Tariff Quotas and Wine) (Amendment etc.) Regulations 2021 and noted that Defra intends to lay the SI at Westminster on 15 May 2021 under the draft affirmative procedure.



Agreed: The Committee wishes it to be clearly understood that due to the lack of information on SI AGS/006 The Common Organisation of the Markets in Agricultural Products (Fruit and Vegetable Producer Organisations, Tariff Quotas and Wine) (Amendment etc. Regulations 2021, and the limited time that it has had to consider it, it has been unable to fully explore and understand the potential impacts and implications to this jurisdiction. This difficulty has been further compounded by the fact that it being asked to do so in the context of the legal uncertainties around the UK Internal Market Bill and the Withdrawal Agreement.

10. Departmental Written Briefing: Statutory Instrument AG/16 The Food and Drink (Miscellaneous Amendments Relating to Food and Wine Composition, Information and Labelling) Regulations 2021

Noted: The Committee considered the Statutory Instrument AG/16 The Food and Drink (Miscellaneous Amendments Relating to Food and Wine Composition, Information and Labelling) Regulations 2021 which does not require the consent of the DAERA Minister and is therefore only for noting.

13. Departmental Written Briefing: Consultation on Proposed Fees and Charges for NI Participants in the UK Emissions Trading Scheme (UK ETS)

Noted: The Committee noted the departmental written briefing on the consultation on the Proposed Fees and Charges for NI Participants in the UK ETS and that the Department will now move to implement the fees and charges.

14. Departmental Written Briefing: Consultation on the Agricultural Wages (Regulations) Order (Northern Ireland) 1977 – Agricultural Wages Board

Agreed: The Committee agreed to write to the Department to request an analysis of the consultation responses.

The Committee considered correspondence from Rural Community Network, which has also issued to the Health Committee on the Rural Needs Assessment which was carried out by the Department of Health in respect of its Mental Health Strategy



2021-2031, in which it was concluded that there was no differential impact based on rural/urban living.

Agreed: The Committee agreed to write to the Department of Health to ask on what basis it concluded that there was no differential impact based on rural/urban living in the Rural Needs Assessment.

The Committee considered correspondence from Minister Poots on Common Frameworks and the JMC (En) Provisional Endorsement of Frameworks and Review of Provisional Frameworks in relation to Article 46 of the Internal Market Act 2000.

Agreed: The Committee agreed to publish the letter from the Minister on the Committee's webpage.

Agreed: The Committee agreed to write to the Minister to request that he keeps the Committee informed of the outworking of the DSO in relation to the Common Frameworks with Section 46 of the Internal Market Act 2020.

The Committee considered correspondence from the Department seeking the views of the Committee on the appointment of a local person to the Office of Environmental Protection (OEP) ahead of the Assembly's approval of the commencement of the relevant provisions of the Environment Bill.

Agreed: The Committee agreed to write to the Department to seek clarification on how the OEP will interface with an independent Environment Protection Agency and the oversight from NI.

Agreed: The Committee agreed to write to the Department to request information on how the appointment will be advertised and how applications will be sought.

Agreed: The Committee agreed to move the departmental oral briefing on Nature Friendly Farming from 13 May to 20 May 2021 due to the unavailability of the lead official.

Agreed: The Committee agreed to write to the Committee for the Executive Office to request that it considers and reports on the provisions allocated within the Bill to the Executive Office.
