5. Oral Evidence Session: DAERA – Climate Change Bill

6. Departmental Written Briefing: Consultation on amendments to the Marine Licensing (Exempted Activities) Order (Northern Ireland) 2011

The Committee considered the departmental written briefing on the proposed consultation on amendments to the Marine Licensing (Exempted Activities) Order (Northern Ireland) 2011 which will launch on 28 May 2021 for a period of 9 weeks. The amendments will ensure that the marine licensing system remains proportionate to the risk to the environment, human health and other uses of the seas to ensure an operation that is efficient and coherent and consistent with marine licensing across Northern Ireland waters and the wider UK.
