1 Apologies

7 Any Other Business

- 7.1 A Member raised an issue with the Ad Hoc Committee on Covid-19 response meeting on 18 March being scheduled at the same time as other Committee meetings, which had prevented a number of Members from participating. The Member noted that there had been two plenary sittings that week at which the Minister could have made the statement and asked if Ministers could be asked to schedule Ad Hoc Committee only at times when there was no other Committees scheduled to meet.
- 7.2 The Speaker advised that Members were aware that he had encouraged Ministers to bring any announcements to the Chamber at the earliest possible opportunity and did not want to make requests that might discourage them from doing so. However, the Speaker accepted that other committee meetings may limit Members' ability to attend meetings of the Ad Hoc Committee, and committed to keep the matter under review.
- 7.3 There was no other business.

- 8.1 Members **agreed** that the next meeting would take place on Tuesday 13 April in the Senate Chamber, Parliament Buildings.
