The meeting commenced in open session at 10:04 a.m.

5. Ministerial briefing on Primary Legislation required for Continued Mitigation of Social Sector Size Criteria

Minister for Communities, Ms Deirdre Hargey MLA and Ms Anne Cleary, Director of Social Security Policy, Legislation and Decision-making Division joined the meeting at 10:12 a.m.

The Minister provided the Committee with an overview of the Primary Legislation required for Continued Mitigation of the Social Sector Size Criteria.

The oral evidence was followed by a question and answer session.

The Chairperson thanked the Minister for her attendance.

The oral evidence was followed by a question and answer session.

The Chairperson left the meeting at 12:30 p.m. The Deputy Chair assumed the Chair at 12:30 p.m.

The Chairperson re-joined the meeting at 12:34 p.m.

The departmental officials agreed to provide further information on a number of issues. These were:

- The Deputy Secretary referred to nine ongoing regeneration projects during her briefing to the committee and members requested more information on these projects.
- Members would like more information on the list of the proposed public realm schemes and details on the level of engagement the department has with other service providers e.g. utilities, in relation to these schemes.
- The committee requested further details on the department's role in the regeneration aspects of the Belfast Region City Deals.
- The committee requested a further briefing from the Deputy Secretary and officials on strategic housing issues.
- The committee was informed that there would be a report on community planning in June 2020 and would like a copy of the report. The committee also requested further information on the links between central and local government and community planning.
- There was a discussion on the recent announcement that Causeway Coast and Glens Council is £68.7m in debt. The departmental officials informed the committee that the Minister had written to the council in relation to this and was awaiting a response. The Committee requested that it be kept informed of developments in relation to this issue.
- The committee requested a copy of the revised code of conduct for councillors and a list of the appeals criteria on PIPS.

 The committee asked to know the reasons behind the decision to take forward a statutory inquiry into the affairs of Woodvale and Shankill Community Housing Association.

The officials briefed the Committee and answered members' questions on statutory rules relating to Houses of Multiple Occupation.

SR 2019/32: The Houses in Multiple Occupation (Code of Practice) Regulations (NI) 2019

The Committee considered SR 2019/32 The Houses in Multiple Occupation (Code of Practice) Regulations (NI) 2019, which would assist councils to operate a licensing scheme to enable better regulation of houses in multiple occupation. The Regulations will provide clarity on requirements of the licensing scheme to ensure that management control of HMOs will be strengthened leading to better standards and housing conditions.

Agreed: The Committee considered SR 2019/32 The Houses in Multiple Occupation (Code of Practice) Regulations (NI) 2019 and had no objection to the rule.

SR 2019/39: The Houses of Multiple Occupation (Commencement and Transitional Provisions) Order (NI) 2019

The Committee considered SR 2019/39 The Houses of Multiple Occupation (Commencement and Transitional Provisions) Order (NI) 2019, which would bring into operation the Houses in Multiple Occupation Act (NI) 2016 as far as it, is not already in operation.

Agreed: The Committee considered SR 2019/39 The Houses of Multiple Occupation (Commencement and Transitional Provisions) Order (NI) 2019 and had no objection to the rule.

SR 2019/34: The Houses of Multiple Occupation (Fees) Regulations (NI) 2019

They also set maximum fee for the supply of a certified copy of an entry relating to an HMO; and a certified copy of its register.

SR 2019/37: The Houses in Multiple Occupation (Space Standard) Regulations (Northern Ireland)

This is to ensure that only spaces that are suitable to sleep and live in are included in any calculation of living space.

SR 2019/38: The Houses of Multiple Occupation (Notice of Application) Regulations (NI) 2019

The Committee considered SR 2019/38 The Houses of Multiple Occupation (Notice of Application) Regulations (NI) 2019, which make provision about the procedural requirements relating to an application for a HMO licence, in particular the requirements for giving notice of the making of applications.
