2. Chairperson's Business

The Committee Chairperson welcomed Fra McCann MLA to the Committee.

8. Consideration of Statutory Rule

SR 2020/26 – The Pneumoconiosis, Etc., (Workers' Compensation) (Amendment) Regulations (Northern Ireland)

The Committee considered The Pneumoconiosis, Etc., (Workers' Compensation) (Amendment) Regulations (Northern Ireland) which would provide lump sum compensation to sufferers of certain dust-related diseases and makes provision for payments to dependants, as defined by the order, where sufferers did not receive a compensation payment under the order before their death.

The Rule will maintain parity with GB when it comes to social security payments and will increase payments in line with the Consumer Price Index.

Agreed: The Committee considered SR 2020/26 – The Pneumoconiosis, Etc., (Workers' Compensation) (Amendment) Regulations (Northern Ireland), and recommended that it be affirmed by the Assembly.

9. Any Other Business

A member raised concerns that legislation for Welfare Reform mitigations had not yet been introduced and that this had serious implications for continuation of payments after 31 March.

Agreed: Members agreed to write to the Department requesting an urgent update on this issue.
