## 2. Chairperson's Business

The Chairperson informed Members that the recent informal stakeholder briefing event on 'Housing' was a success and that she proposed to organise another such event in January 2021.

*Agreed:* The Committee agreed to hold another informal stakeholder briefing event in January 2021.

The Chairperson informed Members that the Minister had offered to brief the Committee on the issues of housing, Casement Park and the Sub Regional Stadia Programme at the meeting on 17 December 2020.

*Agreed:* The Committee agreed to be briefed by the Minister at the meeting on 17 December 2020 and for the meeting to start at 9.00a.m.

The Chairperson informed Members that the Committee had not yet received a Departmental reply to queries on the Musical Instruments for Bands Scheme and that the deadline for applications had now passed.

*Agreed:* The Committee agreed to write to the Minister for an update on the request to extend the deadline for applications.

#### 3. Draft Minutes

*Agreed:* The Committee agreed the minutes of the meeting held on Thursday 19 November 2020.

#### 4. Matters Arising

Members noted a reply from the Ulster Orchestra to Committee queries raised at the meeting on 12 November 2020.

Members noted a response from Sport NI in relation to phase 2 of the Covid-19 sporting grants.

Members noted a response from Belfast City Council in relation to the redevelopment of the former Avoniel Leisure Centre site.

The Chairperson informed Members that they had been provided with a Departmental update on the Covid-19 Charities Fund.

*Agreed:* The Committee agreed to write to the Department to ask for more information on the application criteria, for a list of those charities that were not successful in their applications for funding and the reasons why they were unsuccessful.

#### 5. Briefing by Co3 on the impact of Covid-19 on the Charities Sector

The representatives briefed the Committee and took part in a question and answer session with Members.

The Chairperson thanked the representatives for their attendance.

*Agreed:* The Committee agreed to write to the Department to ask that it reviews and considers removing the restriction of charities holding reserves from the application criteria for the second phase of the Covid-19 Charities Fund. Members also called for the second phase of the fund to be open as quickly as possible rather than the current date in January 2021 and asked that there is flexibility around spend as there is not much time left in the current financial year for funds to be spent. The letter to the Department is also to ask for an update on the status of the concordat agreement between the Department and the Community and Voluntary Sector and whether this will include full cost recovery models.

*Agreed:* The Committee agreed to write to the Chancellor for the Exchequer asking him to consider making an amendment to the furlough scheme so that staff furloughed from charities, particularly those providing specialist services, can subsequently volunteer for their employer.

*Agreed*: The Committee asked Co3 to provide details of what it considers should be included in the criteria for applications to the second phase of the Covid-19 Charities Fund.

*Agreed:* The Committee agreed to write to the Charities Commission to ask what actions they are taking to deal with the backlog of registrations.

*Agreed:* The Committee agreed to write to the Minister for Finance and Minister for Economy to ask that charity shops are included in the recently announced high street voucher scheme.

The meeting was suspended at 11.06a.m. and restarted at 11.10a.m.
