#### This Record of Decisions was made under:

#### Assembly Standing Order 115. Temporary provision for statutory committees

(iii) allow a reasonable time for members to consider the subject matter and supporting information; and

seek consensus among members on the decision.

### 3. Matters Arising

### **Ministerial Written Statement on Small Business Grants**

*Agreed:* the Department to clarify: the timeframe on the £25,000 grant being available; where multiple businesses pay rates through their rent to one landlord, is each business entitled to a grant; whether it is being looked at that businesses with multiple properties each registered as private limited companies are able to obtain support for each property, however other businesses with more than one property can only obtain support for one property; are childcare providers registered as charities and other social enterprises entitled to support or will other support be forthcoming; clarity for the Leisure sector from within the £25k Hospitality Grant i.e. the Grant to extend to golf clubs, sports clubs etc..

*Agreed:* the Department to clarify: businesses who should qualify for SBRR, but because their premises have not been rated or are rated incorrectly fall through the gap for this scheme. Given that Reval 2020 has recently concluded, should these businesses not be captured. Businesses have been advised by LPS to request a rating process, but this can take up to three months. Can this be expedited, given the circumstances, so that these businesses can avail of the grant they are entitled to in theory, if not on paper? Small manufacturing businesses fall out of this scheme. The Minister stated she was keen to find support for these businesses, the Committee to receive an update on this.

## Written Briefing from NI Farms Group

*Agreed:* to forward the briefing to the Department to respond regarding minimum pricing legislation.

*Agreed:* to forward the briefing to the Department for Agriculture, Environment and Rural Affairs regarding emergency aid.

# 4. SR 2020/55 The Health Protection (Coronavirus, Restrictions) Regulations (Northern Ireland) 2020 - as brought forward by the Department of Health

*Agreed:* to ask the Department to confirm: if there has been progress regarding the essential business definition list; on equality impact, while we should adhere to good practice where possible, to also acknowledge the unprecedented and unique conditions we are in; whether guidance has been given where bookings have been made, for example for privately owned caravan parks, in advance that there should be refunds/no charge for those bookings.
