## 4. Ministerial Briefing – Economic Impact of Covid-19

Members received a briefing from:

Mrs Diane Dodds, Minister for the Economy, Department for the Economy.

Key issues discussed included: the work of the Department in supporting business during the current Covid-19 crisis including gaps in the grant schemes; the launch of the RHI consultation tariff review and the commitment to close the RHI Scheme; an update on the Magee College business case; an update on City Deals; the impact of Covid19 on the aviation industry; and support being offered to students in further education.

# 5. Oral Briefing by the Federation of Small Businesses – Update on Economic Impact of Covid-19

Members received a briefing from:

Mr Roger Pollen, Head of External Affairs, Federation of Small Businesses.

Key issues discussed included: the dramatic impact of the lockdown restrictions on those businesses who have close client contact; the gaps in support by the Executive for certain sectors; the impact on social enterprises; and the need for guidance on how businesses could reopen safely to help re-start the economy. *Agreed:* the Committee will raise the issues discussed with the Department and will consider the results of the latest FSB survey once it is published.

# 6. Oral Briefing by Queen's University, Belfast & Ulster University – Update on the Impact of Covid-19

The representatives joined the meeting at 11.42am

Members received a briefing from:

**Professor Ian Greer**, President and Vice-Chancellor, Queen's University Belfast **Professor Paul Bartholomew**, Interim Vice-Chancellor, Ulster University

Key issues discussed included: the role that the Universities will play in economic recovery and growth; the potential operating losses due to Covid-19; the anticipated reduction in international students; the impact of the cap on student numbers and the ability of the Universities to compete with those in GB; and the success of University staff in supporting students and moving to online learning.

Agreed: the Committee agreed to raise the issues discussed with the Department.

Agreed: the Committee agreed to write to the Economy, Finance and Health Ministers urging them to sign-off on the project before the General Medical Council's 30<sup>th</sup> May deadline.

Key issues discussed included; the revising of the budget in light of the current Covid-19 crisis; the revised timeline for the budget process; understanding the scale of funding that may be required by arm's length bodies due to Covid-19 pressures; and the importance of getting the budget right to help the economic recovery.
