Agreed: The Committee agreed to write to the Uniform Youth Work Hub thanking it for the briefing and asking it to:

- Respond indicating how the Department and EA could help its member organisations with pandemic recovery and development of volunteers;
- Provide the Committee with copies of the 'Girls Attitude Survey 2020' and the 'Back in Lockdown' report.

Agreed: The Committee agreed to write to the Minister of Health and the Chief Medical Officer seeking clarity on the date on which voluntary organisations will be able to reopen residential centres and allow camping.

Agreed: The Committee agreed to write to the Education Authority:

- Asking what information was available on the impact on Child Mental Health due to the Covid-19 pandemic;
- Asking for an update on its new funding scheme and what it can do to make its funding more accessible by voluntary sector outdoor centres; and
- Asking what provision could be made to resource voluntary organisations via training and development to reach out to vulnerable children in particular.

Agreed: The Committee agreed to write to the Department for Communities indicating the willingness of uniform organisations to participate in the development of outreach policy for looked after children.

Agreed: The Committee agreed to write to the Women's Caucus and the Committee for Justice indicating Girlguiding Ulster's willingness to arrange focus groups on safety and sexual violence.

- Analysis of the increase in statistics for looked after children due to the pandemic, and of differences in approach to these children in NI compared to that in neighbouring jurisdictions; and
- An update on the Department's response to the recommendations in the 'Elephant in the Room' report.

- information on the confidentiality of services dealing with children and young people; and
- Information on the capacity of CAMHS.
