5. UK Exit from European Union – Oral Evidence Session with Junior Ministers on Brexit Issues.

The Junior Ministers joined the meeting at 2:07pm

The Junior Ministers briefed Members on EU Exit matters.

The oral evidence was followed by a question and answer session.

During the evidence the Junior Ministers agreed to provide the Committee with further information on the checks and controls at border control posts.

The Chairperson thanked the Junior Ministers for their attendance.

Agreed: The Committee agreed to write to the Executive Office to ask for information on EU funding streams, value of the EU funds that have been, or will be, discontinued as a consequence of EU Exit, and details of the shortfall of funds intended to replace them following EU Exit.
