The Committee considered the SL1 - Census Order (Northern Ireland) 2020 which is the largest and most complex statistical exercise undertaken by Government and traditionally occurs once every 10 years.

Agreed: That the Committee has considered the Department of Finance's proposal

for subordinate legislation The Census Order (Northern Ireland) 2020, and has no objection to the policy implications of the proposed legislation at

this stage.

Agreed: To inform the Committee for the Executive Office that the Committee for

Finance has no objections to the policy implications of this proposed

legislation at this stage.

## 8. SL1 – The Whole of the Government Accounts (Designation of Bodies) Order (Northern Ireland) 2020

The Committee considered the SL1 – The Whole of the Government Accounts (Designation of Bodies) Order (Northern Ireland) 2020 which enables the Department of Finance to request information from those departments and bodies designated in the Schedule to the Order and to pass the information provided to HM Treasury for use in the preparation of the Whole of Government Accounts (WGA).

Agreed: That the Committee has considered the Department of Finance's proposal

for subordinate legislation The Whole of Government Accounts (Designation of Bodies) Order (Northern Ireland) 2020 and has no objectives to the policy implications of the proposed legislation at this

stage.

#### 9. SL1 – The Public Service Pensions Revaluation Order (Northern Ireland) 2020

The Committee considered the SL1 – The Public Service Pensions Revaluation Order (Northern Ireland) 2020 which specifies the annual percentage change in prices and earnings for the purposes of revaluation of pension benefits accrued by active members in Career Average Revaluated Earnings (CARE) public service pension schemes.

Agreed: That the Committee has considered the Department of Finance's proposal

for subordinate legislation The Public Service Pensions Revaluation Order (Northern Ireland) 2020 and has no objection to the policy implications of

the proposed legislation at this stage.

Agreed: To ask the Department to outline the reason why the Committee was not

afforded the time for consideration, given that this is routine legislation

which is updated annually.

Agreed: To ask the Department why the Committee was not notified earlier that

there may be a delay in bringing forward the legislation.

## 7. Oral Evidence – The Rates (Small Business Hereditament Relief) (Amendment) Regulations (NI) 2020

The Committee considered correspondence from the Department of Finance advising that the policy on non-domestic rates for 2020-2021 is changing rapidly as a result of external circumstances and the draft legislation to which the SL1 relates may now need to be revised. The oral evidence session was, therefore, postponed.

Agreed: The Committee were content to receive a written briefing in relation to a

number of matters relating to support for businesses.

### 10. Written Briefing - Chancellor's Budget 2020-2021

The Committee considered a draft memo from the Clerk to be circulated to clerks of statutory committees to inform of the indicative timing of the Executive Budget 2020-2021 and asking for co-operation to follow a single agreed process of budget scrutiny.

Agreed: The memo was approved.

Agreed: To forward the memo to the clerks of statutory committees.

The Committee was informed that an LCM on an emergency Coronavirus Bill may be tabled for debate.

Agreed: The Committee agreed to consider holding an additional meeting if

there is an LCM on an emergency bill which requires detailed consideration by the Committee in advance of a debate in plenary.

The Committee considered the Department's request to defer the evidence on the review of financial process until after the Budget is announced.

Agreed: To defer the item.

The Committee noted that the Minister of Finance will write to the Committee with an initial brief on the Renewable Heat Incentive (RHI) Inquiry Report and will provide a more substantive briefing once the report has been analysed.

The Committee considered the Functioning of Government (Miscellaneous Provisions) Bill which passed the 2<sup>nd</sup> Stage and was referred to the Committee for Finance.

Agreed: To request written evidence from the identified groups and individuals and

to include the Commissioner for Public Appointments.

Agreed: To commission research on a number of issues relating to the Bill from the

NI Assembly researchers.

Agreed: The Committee agreed the Forward Work Programme.

## 16. Any Other Business

The Committee noted a letter from the Minister of Finance on transparency, accountability and the functions of the Executive.

The Committee noted a press release from the Minister of Finance regarding the NICS disciplinary process for cases arising from the Renewable Heat Incentive Inquiry.

The Committee noted a press release from the Minister of Finance regarding RHI recommendations.

The Committee considered correspondence from the Clerk to the Committee on Procedures seeking the Committee's view on the review of Legislative Consent Motions (LCM).

Agreed: To review the Committee for Finance & Personnel's consideration of

LCMs during the 2011-2016 mandate.
