3. Matters Arising

The Committee considered the Department's request to defer the Committee's request for minutes and involvement of, and interaction with the NIO for the RHI tariffs as set out in the Regional Rates and Energy (No.2) Act until a later date.

4. Written Evidence: Department of Finance (DoF) Public Spending Directorate - Budget 2020-21 process

The Committee considered the written evidence provided by the DoF Public Spending Directorate.

Agreed: To forward the paper on Written Evidence to the House of Commons NI

Affairs Committee from Esmond Birnie to RaISe for an analysis/response to the issues highlighted for consideration on or before 29 April and to forward the paper to other statutory committees to inform their budget

scrutiny.

Agreed: To ask RaISe to review and clarify the terminology at page 25 of the

template regarding 'non-block allocations' and, if possible, confirm that

departmental Finance Divisions will understand the terminology.

Agreed: To check and clarify the resource figure for the Budget at page 33 of the

Clerk's brief and email Committee members.

Agreed: To forward standardised scrutiny approach templates on the forthcoming

Executive Budget 2020-2021 to the Department's Finance Division

requesting a return date of 15th April for Committee Consideration on 22

April.

Agreed: To forward the completed templates to RaISe in order to inform the

collated response from this Committee.

Agreed:

To receive clarification on a number of issues raised in relation to the written briefing by the Public Spending Directorate including the allocation of the remainder of the £760m, the £4m of NI specific issues and the £85m for the Agenda for Change pay.

5. Written Evidence: Departmental Solicitor's Office - Overview and priorities

The Committee considered the written evidence on the overview and priorities from the Departmental Solicitor's Office (DSO).

Agreed:

To review the correspondence previously received to check whether it contains the staff complement for DSO and, if so, to forward to members.

6. SL1 - The Pensions Increase (Review) Order 2020

The Committee considered the SL1 – The Pensions Increase (Review) Order 2020. This legislation fulfils the Department of Finance's obligation to provide, by Order, for an increase in the rates of Northern Ireland public service pensions in payment and deferred pensions of 1.7% with effect from 6 April 2020.

Agreed:

That the Committee has considered Department of Finance's proposal for subordinate legislation The Pensions Increase (Review) Order 2020, and has no objection to the policy implications of the proposed legislation at this stage.

7. Private Members Legislation: The Functioning of Government (Miscellaneous Provisions) Bill

The Committee considered a number of issues relating to the Private Members Legislation: The Functioning of Government (Miscellaneous Provisions) Bill including the timeline and invitations for oral and written evidence.

The Committee considered a proposal from Dr. Steve Aiken MLA in relation to an extension to the timeline of committee scrutiny of the Bill.

Ireland Assembly Communications Office.

Agreed: Not to hold a Committee meeting on 1 April 2020.

Agreed: The Committee agreed the Forward Work Programme.
