3. Oral Evidence Session: Reported Joint Order for Personal Protective Equipment between the Department of Finance and the Government of the Republic of Ireland

The oral evidence session was reported by Hansard.

The Minister and the Permanent Secretary provided an update on the reported joint order for Personal Protective Equipment (PPE) which was understood to have been placed by the Department of Finance (DoF) with the Government of the Republic of Ireland (RoI).

This was followed by a question and answer session.

The Committee considered the timeline for the placement of the reported joint order and issues relating to securing the procurement of PPE in a competitive global market including the establishment of a multi-disciplinary Department of Finance-led team and opportunities for the stock-piling and/or sharing of PPE with other jurisdictions.

Mr McHugh asked that the minutes formally record that Mr Frew's questions in respect of the reported joint order had not previously been forwarded by the Committee to the Minister for a response.

Agreed: The Committee agreed to write to the Minister requesting, as soon as

possible, sight of the paper trail for the reported joint order including

relevant emails between DoF/RoI officials.

Agreed: The Committee further agreed to write to the Minister seeking a written

timeline for the reported joint order and details of the PPE which had been sought as well as responses to Mr Frew's questions, raised on 1

April 2020, in relation to the reported joint order.

Agreed: The Committee also agreed to ask the Minister to provide information

on all PPE sourcing endeavours by the Central Procurement Directorate for both the immediate and longer term and clarification in respect of arrangements for sharing/stock-piling of PPE across the United

Kingdom and including with the RoI.

The Chairperson thanked the Minister and the Permanent Secretary for their attendance.

The Minister and Permanent Secretary left the meeting at 4.58pm
