Issues discussed included: A new statutory duty for Departments to comply in providing information before implementing Section 44 and sanctions; criminal offence for failure to use non-official systems and the transfer of information to official systems; maintaining the dates identified in Clause 4 due to COVID-19; Codes vs legislation.

5. SR 2020/144: The Rates (Coronavirus) (Emergency Relief) (No.2) Regulations (Northern Ireland) 2020

The Committee for Finance considered SR 2020/144 – The Rates (Coronavirus) (Emergency Relief) (No.2) Regulations (Northern Ireland) 2020. The rule is to make provision to provide emergency rate relief in order to help business ratepayers who are facing financial impacts arising from the serious public health issues caused by Coronavirus.

Agreed: The Committee for Finance considered SR 2020/144 – The Rates

(Coronavirus) (Emergency Relief) (No. 2) Regulations (Northern Ireland)

2020 and has no objection to the rule.

6. SR 2020/160: The Rates (Automatic Telling Machines) (Designation of Rural Areas) Order (Northern Ireland) 2020

The Committee for Finance considered SR 2020/160 – The Rates (Automatic Telling Machines) (Designation of Rural Areas) Order (Northern Ireland) 2020. The rule updates the eligible wards for the purpose of providing a rates exemption to Automatic Telling Machines in these areas.

7. SR 2020/161: The Valuation (Telecommunications, Natural Gas and Water) (Amendment) Regulations (Northern Ireland) 2020

The rule amends the Schedule to the principal Regulations to provide an update of the telecommunication companies laid out in Part 1 of the Schedule to the principal Regulations.
