7. SL1 – The Rates (Coronavirus Emergency Relief) Regulations (Northern Ireland) 2020

The oral evidence session was reported by Hansard.

The Committee considered the SL1 – The Rates (Coronavirus Emergency Relief) Regulations (Northern Ireland) 2020. The Rule is to make provision to provide emergency rate relief in order to help business ratepayers who are facing financial impacts arising from the serious public health issues caused by Covid-19. The draft Rule will intervene for a three-month period in order to provide 100% rate relief for businesses. This emergency policy intervention will apply to all business properties with the exception of public bodies and utility providers/statutory undertakers.

Agreed: Members agreed that questions concerning matters that are not directly

related to the provisions in the Statutory Rule should be emailed to the

Clerk for a written response from the official.

Agreed: That the Committee for Finance has considered Department of Finance's

proposal for subordinate legislation The Rates (Coronavirus Emergency

Relief) Regulations (Northern Ireland) 2020 and has no objection to the policy implications of the proposed legislation at this stage

8. SL1 – The Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2020

The Committee considered the SL1 - to the purpose of the draft Rule is to extend the Small Business Rate Relief Scheme up to 31 March 2021.

Agreed:
