4. The impact of the Chancellor's decision to cancel the UK Budget on the Assembly Budget for 2021-22: Minister of Finance

The Minister and official joined the meeting at 14.07pm

The oral evidence session was reported by Hansard.

Issues discussed included: Comprehensive Spending Review and one-year budget; expected timeline for the UK Budget of late November, consultation and agreement on the Northern Ireland Budget 2021-2022; Treasury discussions on the flexibility of transferring capital to resource; the impact of Brexit including, the Northern Ireland Protocol and the Internal Market Bill; October Monitoring Round; State Aid; funding business and individuals not in mainstream funding programmes; SIB support to department's to manage loans from Financial Transaction Capital projects; the need for greater budget transparency; procedures for granting expenditure under sole authority of a Budget Act; and the development of the Procurement Board and Fiscal Council.

Agreed: To provide the Committee with a response on a range of issues.

5. SR 2020/221 The Financial Assistance (Coronavirus) Regulations (Northern Ireland) 2020

Ian Snowden, Chief Executive of Land and Property Services, Department of Finance joined the meeting at 15.35pm

Issues discussed: changes to the SR since the Committee considered the SL on 7 October 2020 and the background to the SL1 The Financial Assistance (Coronavirus) (No. 2) Regulations (Northern Ireland) 2020.

The Committee considered SR 2020/221 The Financial Assistance (Coronavirus) Regulations (Northern Ireland) 2020 and the written response by the Department to changes since it was considered by the Committee on 7 October 2020. The purpose of Rule will be to implement a scheme which the Department has been designated to enact. The scheme implemented by the proposed Rule will provide financial assistance to businesses whose ability to trade is directly affected by the COVID-19 restrictions. The Regulations are subject to the negative resolution.

The purpose of the draft Rule to which this SL1 letter refers, will be to implement the scheme which the Department has been designated to enact, and to revise the previous scheme to increase the level of assistance provided for the duration of the scheme. The rule is subject to Negative Resolution Assembly procedure.

6. SL1 Draft Administration of Estates (Small Payments) (Increase of Limit) Order (Northern Ireland) 2020

The Committee considered the SL1 – Draft Administration of Estates (Small Payments) (Increase of Limit) Order (Northern Ireland) 2020. The purpose of the draft Rule will increase the small payments limit, from £10,000 to £20,000, on the amount of money that may be released to the beneficiaries of a deceased person from that person's estate by certain organisations without the need for a grant of probate. The rule is subject to subject to Affirmative Resolution Assembly procedure.
