Issues discussed included: OECD implementation and the need to achieve the final delivery; support for major and minor transformative programmes including pay policy, fiscal reform and the change to European directives; the growth of iLabs and the numerous recommendation implemented; COVID-19 and the impact of working from home/hubs through gathering relevant data and including wellbeing, the review of Arms-Length-Bodies for efficiency and managing a cultural shift.

Agreed:	To ask the Department if NISRA is collating data in relation to homeworking and, if so, to update the Committee on how this is progressing.
Agreed:	The Committee to receive the overarching mission statement for PSRD.
Agreed:	The Committee to receive an updated organisation structure diagram for the Department of Finance.
Agreed:	To maintain a watching brief on the implementation of OECD recommendations by PSRD.
Agreed:	The Committee to receive more detail on the purpose, intended outcomes and time frame of the review of Arms-Length Bodies.
Agreed:	To schedule further work on the Voluntary Exit Scheme following the publication of the report by the NIAO.
Agreed:	To commission research from RaISe to review the OECD recommendations from 2016 following the publication of the NIAO and other relevant reports.

## 6. SL1 – The Business Tenancies (Coronavirus) (Restriction on Forfeiture: Relevant Period) (Northern Ireland) (Amendment) (No.2) Regulations 2020

The Committee considered the SL1 – The Business Tenancies (Coronavirus) (Restriction on Forfeiture: Relevant Period) (Northern Ireland) (Amendment) (No. 2) Regulations 2020. The purpose of the draft Rule is Section 83 of the Coronavirus Act 2020 provides that a right of re-entry or forfeiture, under a relevant business tenancy, for non-payment of rent may not be enforced, by action or otherwise, during the relevant period. "Relevant period" is currently defined in subsection (7) as the period starting with Royal Assent and ending with 30th September 2020. This Draft rule would extend the "relevant period", for the purposes of section 83 of the Coronavirus Act 2020, to 31st December 2020.

*Agreed:* To ask the Department to extended the relevant period for the purposes of section 83 of the Coronavirus Act 2020 to 31 March 2021 rather than to 31 December 2020 as proposed in the SL1.
