## 7. Legislative Consent Motion: The Medicines and Medical Devices Bill - Committee Draft Report

The Committee considered a draft report on its consideration of the Legislative Consent Memorandum on the provisions of the Medicines and Medical Devices Bill to be extended to Northern Ireland and the Legislative Consent Motion to be brought forward by the Minister for Health.

Ms Cathy Harrison, Chief Pharmaceutical Officer, Department of Health, joined the meeting at 1.00 pm and answered a number of Members' questions on the LCM.

The Chairperson thanked Ms Harrison for her attendance.

The Committee discussed its options relating to the content of its draft report and its response to the motion being brought to the Assembly by the Minister of Health:

*“That this Assembly endorses the principle of the extension to Northern Ireland of the provisions within the Medicines and Medical Devices Bill as introduced to Parliament on 13 February 2020 dealing with human medicines and veterinary medicines.”*

The question was put that that the report concludes that there has been insufficient time and opportunity for scrutiny in order to come to a view.

**8. SR 2020/73 The Misuse of Drugs (Amendment) Regulations (Northern Ireland) 2020**

The Committee considered SR 2020/73 The Misuse of Drugs (Amendment) Regulations (Northern Ireland) 2020 which would facilitate the dispensing of medicines during the pandemic.

The Committee noted that the Examiner of Statutory Rules had reported a breach of the 21-day rule in respect of this statutory rule but was content that the Department had provided a satisfactory reason for the breach.

*Agreed:* The Committee has considered SR 2020/73 The Misuse of Drugs (Amendment) Regulations (Northern Ireland) 2020 and has no objection to the Rule.

**9. SL1 The Misuse of Drugs (Amendment No. 2) Regulations (Northern Ireland) 2020**

Officials from the Department of Health joined the meeting at 1.32 pm.

The officials briefed the Committee on the Department's proposal to make a statutory rule to amend the Misuse of Drugs Regulations (Northern Ireland) 2020 to allow for fewer restrictions on the prescribing and supply of the cannabis-based medicine, Epidyolex.

The briefing was followed by a question and answer session.

The Chairperson thanked the officials for their attendance.

*Agreed:* The Committee agreed that it was content with the proposal for the Statutory Rule.

The briefing session was reported by Hansard.

## **10. SL1 The Addition of Vitamins, Minerals and Other Substances (Amendment) Regulations (Northern Ireland) 2020**

The Committee considered a proposal by the Food Standard Agency to make a Statutory Rule to amend The Addition of Vitamins, Minerals and Other Substances Regulations (Northern Ireland) 2007, which would provide for the enforcement of Regulation (EC) No 1925/2006 on the addition of vitamins and minerals and of certain other substances to foods.

*Agreed:* The Committee agreed that it was content with the proposal for the Statutory Rule.

## **11. Correspondence**

- ii. The Committee noted a briefing paper from the Minister of Health providing an update on payments to those affected by the contaminated blood issue.

- vi. The Committee considered correspondence from an individual regarding guidelines relating to the administration of vitamin B12 injections.

*Agreed:* The Committee agreed to request information from the Department of Health on the dissemination and implementation of the guidelines.

- vii. The Committee noted a copy of correspondence from the Committee for the Economy to the Department of Health seeking clarification on how the Health Protection (Coronavirus Restrictions) Regulations (NI) 2020 affect the work of estate agents.

*Agreed:* The Committee agreed to consider this matter further when it had received the Department of Health's response to the Economy Committee.

- viii. The Committee noted correspondence from the Department for Communities regarding funding and support for the work of the Hourglass charity.
- ix. The Committee noted the Examiner of Statutory Rules' twelfth report of session 2019-2020.
- x. The Committee noted a RaISE article on the use of widespread testing and contact tracing as part of the solution to exiting 'lockdown'.
- xi. The Committee considered correspondence from Families Involved NI (FINI) regarding the impact of the COVID-19 pandemic on carers responsible for providing care to family members with disabilities.

*Agreed:* The Committee agreed to flag the issues raised in the FINI correspondence with the Department of Health.

*Agreed:* The Committee agreed to schedule a briefing session with representatives of carers organisations.

- xii. The Committee noted correspondence from the Minister of Health advising of his decision to temporarily change the current governance and accountability arrangements in the Health and Social Care Framework document and the publication of the 'Strategic Framework for Rebuilding Health and Social Care Services.'
- xiii. The Committee noted a copy of correspondence from the Committee Clerk to a Committee Member regarding the arrangements for the first expert panel session held on 14 May 2020.

## **12. Forward Work Programme**

The Committee noted its Forward Work Programme.

The Chairperson advised Members that it had not been possible to make arrangements to meet the Health Minister on 24 June and this had been rescheduled to take place on Monday, 22 June at 3.00 pm.
