#### 2. Chairperson's Business

  - **Agreed:** The Committee agreed to ask the Committee Clerk to consider terms of reference for a potential inquiry on waiting times.
  - Agreed: The Committee agreed to write to the Executive to indicate the Committee's concern in relation to this matter, to seek an Executive meeting on this matter and to indicate the Committee's commitment to support concentrated and concerted efforts by the Executive to address waiting lists.

  - Agreed: The Committee agreed to request further information from the Department on the percentage uptake of the vaccine by ethnic background and to ask what actions are being taken to address low uptake in particular communities.

- vii. The Committee noted correspondence from RNIB NI on the provision of support for blind and partially sighted people during the pandemic.

ix. The Committee noted a copy of correspondence from the House of Lords European Affairs Sub Committee on the Protocol on Ireland/ Northern



Ireland to Lord Bethell, Parliamentary Under-Secretary of State regarding a regulation amending the annexes to No 852/2004 of the European Parliament and of the Council on Hygiene of Foodstuffs as regards food allergen management, redistribution of food and food safety culture.

- x. The Committee noted correspondence from the Committee for Finance requesting its views on the establishment of an Independent Fiscal Council for Northern Ireland and the potential role and powers for such a council.
- xi. The Committee noted correspondence from an individual regarding the Mother and Baby Institutions.
- xii. The Committee noted correspondence from an individual regarding the Report of the Inquiry into Hyponatremia-related Deaths.
- xiii. The Committee considered correspondence from the Minister of Health providing an update on the development of proposals for a new regional model of service for separated and unaccompanied asylum seeking children.
  - Agreed: The Committee agreed to request that it is provided with a copy of the responses from the Children's Law Centre, the NI Human Rights Commission and the NI Commissioner for Children and Young People to the Department's consultation on this matter.
- xiv. The Committee noted correspondence from the Minister of Health providing notice of his intention to publish jointly with the Minister for Justice, the Private Family Law Early Resolution Action Plan.
- xv. The Committee noted correspondence from the BT Group requesting support for the launch of Hope United, a team of football players who have come together to tackle online hate.
- xvi. The Committee considered correspondence from 123 GP requesting that the Committee write to the Health Minister to ask that he includes



commitments to the provision of counselling within the mental health strategy.

**Agreed:** The Committee agreed to write to the Health Minister to ask that he includes a commitment to counselling within the mental health strategy.

#### 9. SR 2021/121 The Health Protection (Coronavirus, International Travel) (Amendment No. 2) Regulations (Northern Ireland) 2021

Elaine Colgan, Head of Health Protection Branch, Department of Health joined the meeting by video-conference at 1.42 pm and briefed the Committee on two international travel restriction regulations (agenda item 8 and additional agenda item 9).

A question and answer session followed.

The official agreed to provide further information on managed isolation.

The Chairperson thanked Elaine Colgan for attending.

The briefing session was report by Hansard.

The Committee considered SR 2021/121 The Health Protection (Coronavirus, International Travel) (Amendment No. 2) Regulations (Northern Ireland) 2021 which: amends fixed penalties in relation to a particular managed isolation offence; adds the Maldives, Nepal and Turkey to the red list of countries; adds an additional exemption for transit passengers who arrive into Northern Ireland and immediately travel directly to the Republic of Ireland; and prohibits the arrival of aircraft and vessels from the Maldives and Turkey.



Agreed: The Committee considered SR 2021/121 The Health Protection (Coronavirus, International Travel) (Amendment No. 2) Regulations (Northern Ireland) 2021 and agreed it had no objection to the Rule.

The Committee agreed to consider an addition agenda item, SR 2021/132 The Health Protection (Coronavirus, International Travel) (Amendment No. 3) Regulations (Northern Ireland) 2021.

#### 10.SR 2021/132 The Health Protection (Coronavirus, International Travel) (Amendment No. 3) Regulations (Northern Ireland) 2021

The Committee considered SR 2021/132 The Health Protection (Coronavirus, International Travel) (Amendment No. 3) Regulations (Northern Ireland) 2021 which: adds a number of countries to the green list countries; excludes seafarers and inspectors and surveyors of ships who work on cruise ships from the exemptions relating to managed self-isolation for red list arrivals; and prohibits the arrival of aircraft and vessels from Turkey.

Agreed: The Committee considered SR 2021/132 The Health Protection (Coronavirus, International Travel) (Amendment No. 3) Regulations (Northern Ireland) 2021 and agreed it had no objection to the Rule.
