### 1. Apologies

# 2. Chairperson's Business

- i. The Chairperson provided an update on an informal meeting that he had held with representatives from the Royal College of Surgeons.
- ii. The Chairperson advised that a meeting with individuals affected by the independent investigation into mother and baby homes has been arranged to take place on 16 February.

#### 3. Matters Arising

The Chairperson referred to the Committee's consideration, at last week's meeting, of SR2021/8 The Mental Health (1986 Order) (Amendment) Order (Northern Ireland) 2021 and updated the Committee on his meeting with the Chief Commissioner of the NI Human Rights Commission to discuss this statutory rule.

- *Agreed:* The Committee agreed to ask the Department of Health for detail on what treatments are included within the scope of these regulations and to seek assurance from the Department that those patients with more invasive treatments will be prioritised.
- Agreed: The Committee agreed to request that the Department consult organisations such as the NIHRC when drafting legislation that affect those accessing mental health services.

### 4. COVID-19 Disease Response - Ministerial Update

The Minister of Health, Mr Robin Swann MLA, and the Chief Medical Officer, Dr Michael McBride joined the meeting via video-conference at 9.38 am.

The Minister provided an update on the Department of Health's response and planning in relation to COVID-19.

The briefing was followed by a question and answer session.

The Chairperson thanked the Minister and Dr McBride for their attendance.

#### 7. Correspondence

- i. The Committee considered a response from the Minister of Health to the Committee's request for information on matters arising from the O'Hara report on hyponatraemia related deaths.
  - *Agreed:* The Committee agreed to ask the Department of Health for a further update on its work to respond to the findings of the O'Hara report on hyponatraemia related deaths and on matters arising from the report.
  - *Agreed:* The Committee agreed to schedule a briefing in relation to the Department's response to the inquiry on hyponatraemia related deaths.
- ii. The Committee considered a response from the Minister of Health to the Committee's request for information on the HSC workforce appeal campaigns.
  - *Agreed:* The Committee agreed to request further detail from the Department of Health in relation to this matter.

- iii. The Committee noted correspondence from the Minister of Health regarding the January 2021 Budget monitoring position.
- iv. The Committee considered correspondence from the Minister of Health regarding the treatment and aftercare for people experiencing the long-term effects of COVID-19.

*Agreed:* The Committee agreed to request that it is kept updated by the Department of Health in relation to this matter.

v. The Committee considered correspondence from the Minister of Health regarding the impact of COVID-19 on living and deceased organ transplant disposal.

*Agreed:* The Committee agreed to note the correspondence pending consideration of further updates on this matter.

vi. The Committee considered an invitation from the Voice of Young People in Care to attend a virtual roundtable discussion on its recent research report on the experience of young people leaving care during the COVID-19 pandemic.

- vii. The Committee considered responses from Asthma UK and the British Lung Foundation NI and Cancer Focus NI to the Committee's request for their views on the services provided to those suffering from mesothelioma.
  - *Agreed:* The Committee agreed to forward both items of correspondence to the Department of Health for a response to the issues raised; express concern at the poor survival rates as outlined in the correspondence; to ask whether the Department plans to introduce a service model similar to the Scottish model; and request information relating to the roll out of best practice services across the UK.
  - *Agreed:* The Committee agreed to advise the individual who had originally raised this matter with the Committee of the actions taken.
- viii. The Committee noted a copy of correspondence from the Committee for Justice to all Executive Ministers regarding the Damages (Return on Investment) Bill.
- ix. The Committee noted correspondence from an individual regarding concerns arising from the discussion at the Committee meeting on 4 February regarding a social media post shared by a member of the Board of the Education Authority.
- x. The Committee noted the Forum for Adult Learning NI 'Learn Well, Live Well Report: adult learning & health and wellbeing' and an invitation to the launch of the report.

*Agreed:* The Committee agreed that Members would respond directly to the invitation.

- xi. The Committee noted a copy of correspondence from the Committee for Finance to the Minister for Health regarding the timescales for when those categorised as clinically extremely vulnerable can expect to be vaccinated and would be safe to resume employment.
- xii. The Committee noted a copy of correspondence from the Committee for Communities to the Minister for Health to request an update on the consultation on minimum unit alcohol pricing and to consider the Committee's request for increased funding for alcohol advice and addiction services.
- xiii. The Committee noted correspondence from Ms Órlaithí Flynn MLA regarding her proposal to take forward a Private Members Bill on Suicide Prevention Training.
- xiv. The Committee considered correspondence from an individual highlighting concerns about COVID-19 restrictions on sport and its impact on mental health.

  - *Agreed:* The Committee agreed to seek further information relating to the terms of reference for the inquiry.
- xviii. The Committee noted correspondence from the Minister of Health advising that the UK government is to lay a new statutory instrument in Westminster regarding the implementation of the EU Medical Device Regulations in Northern Ireland.
