## Re: Protests at premises providing abortion services

In response to your letter received on 11<sup>th</sup> June 2021 requesting information on measures taken by Health & Social Care Trusts to address concern that both patients and staff may feel intimidated and harassed by protesters, please find our position outlined below:

- All patients and staff should be able to access any health care facility for any treatment free from harassment, intimidation and confrontation.
- The Trust had been providing the Early Medical Abortion (EMA) service in Coleraine Community Clinic from January 2021. The service has requested to be transferred due to concerns about patient and staff confidentiality, and the on-going impact on all service users of the personal and abusive protests around these facilities.
- The Trust is actively scoping an alternative area to relocate the EMA service.
- The Trust has not publicly confirmed the current locations of the EMA service, but there are now weekly protests on the public highway outside Coleraine Community Clinic.
- We have been liaising regularly with the PSNI and the EMA team has been using the datix system to record any incidences relating to these weekly protests.
- As a Trust a provider of health care services we have no powers of enforcement in relation to public protests. We can raise concerns but have no authority to take any measures to prevent lawful protest on a public highway. Therefore any measures to address these protests will be a matter for the PSNI.
