3. Matters Arising

Budget Bill 2020 and Departmental Resource Requirements

The Committee considered a memo from the Committee for Finance regarding the timescale for departments to provide details of resource requirements for 2020/21 to the Department for Finance and for the introduction of the Budget Bill to the Assembly.

The Committee noted that an oral evidence session on the Department of Justice resource requirements for 2020-21 had been provisionally scheduled for the meeting on 20 February.

Agreed:	The Committee agreed to write to the Minister for Justice to emphasise the importance of the Committee getting as much detailed information as was available on the 2020-21 budget bids/requirements, pressures and priority areas to enable it to assess the position in advance of the Assembly debates on the budget.

The Committee noted that the Examiner of Statutory Rules had no issues to raise with the technical elements of the following Statutory Rules:

- S.R. 2020/11: The County Court (Amendment) Rules (Northern Ireland) 2020
- S.R. 2020/13: The Police Service of Northern Ireland (Amendment) Regulations 2020

7. Correspondence

- i. The Committee considered correspondence from the House of Lords European Union Committee inviting Members to attend a working lunch on Tuesday 25 February in Parliament Buildings to discuss how it might work with Assembly Committees on scrutiny of the Protocol on Ireland/Northern Ireland and other issues arising from the UK's exit from the EU and requesting views on the European Commission's Recommendation for a Council Decision authorising the opening of negotiations for a new partnership with the United Kingdom and the UK Government's written ministerial statement of 3 February on UK/EU relations.

 - *Agreed:* Members agreed to advise the Clerk if they wished to participate in the roundtable seminar in the morning of Tuesday 25 February or observe the afternoon evidence sessions.
 - *Agreed:* The Committee agreed to invite the Assembly EU Affairs Officer to provide a briefing in closed session on the UK's exit from the EU and justice related issues.
 - *Agreed:* The Committee agreed to write to the Department of Justice and request a briefing paper setting out the position on all Brexit-related justice issues.
- ii. The Committee considered an invitation from Mid Ulster Council to hold a Committee Meeting at a council facility.
 - *Agreed:* The Committee agreed to give further consideration to holding a meeting at Mid Ulster Council premises when considering its strategic priorities and programme of visits.
- iii. The Committee considered an invitation from the Bar of Northern Ireland, to an event on "Defending Democracy The Law in an Era of Fake News" on Wednesday 26 February in the Inn of Court, Royal Courts of Justice.

Agreed: Members agreed to advise the Clerk if they wished to attend the event.

iv. The Committee noted a letter from the Department of Justice providing information on the dates for publication of Northern Ireland Courts and Tribunals Service quarterly statistical bulletins on civil, criminal and family business across all court tiers.

The Chairperson informed Members that he had received a request from the Chief Commissioner of the Northern Ireland Human Rights Commission for an introductory meeting and arrangements will be made for this to take place.

The Chairperson informed Members that he had received a request from the Chair and Chief Executive of the Consumer Council for a meeting. Given the work highlighted in the letter was not justice related, the Chairperson advised the Committee that he had asked the Clerk to contact them regarding any future justice-related work that may be relevant to the Committee.

Terrorist Offenders (Restriction of Early Release) Bill

The Chairperson raised the issue of the Terrorist Offenders (Restriction of Early Release) Bill currently progressing through Westminster, which would not apply to Northern Ireland.

Agreed: The Committee agreed to write to the Minister of Justice to request information on what communication/discussion had taken place on including Northern Ireland in the legislation and what engagement would now take place on the implications for Northern Ireland of not being included in the legislation.
