## **5. Domestic Abuse and Family Proceedings Bill – Proposals for Committee Stage**

The Committee considered a provisional timetable for the Committee Stage of the Domestic Abuse and Family Proceedings Bill and proposals to seek written evidence on the Bill including a draft media sign-posting notice, a draft letter seeking evidence on the Bill and a list of key stakeholders.

*Agreed:* The Committee agreed that it was content with the proposed timetable for the Committee Stage of the Bill.

*Agreed:* The Committee agreed that it was content with the media sign-posting notice, the list of key stakeholders and the letter to issue seeking written evidence on the Bill including the areas on which views would be particularly welcome.

## **6. Legislative Consent Motion - Private International Law (Implementation of Agreements) Bill – Draft Committee Report**

The Committee considered a draft report on the Legislative Consent Memorandum on the provisions in the Private International Law (Implementation of Agreements) Bill to be

extended to Northern Ireland and the Legislative Consent Motion to be brought forward by the Minister of Justice.

The Deputy Chairperson, Ms Dillon, placed on record her continuing concerns regarding the regulation-making powers at Clause 2 of the Bill which allows the UK Government to implement international agreements on PIL in domestic law in future via secondary legislation and indicated that she was not content with the explanations provided in relation to this issue but would not object to the LCM proceeding.

## **7. Legislative Consent Motion - – Provisions Relating to Extra Territorial Jurisdiction in the UK Domestic Abuse Bill**

The Committee considered information provided by the Department of Justice on a proposal for a Legislative Consent Motion to extend the provisions relating to extra-territorial jurisdiction in the UK Domestic Abuse Bill to Northern Ireland.

*Agreed:* The Committee agreed that it was content with the proposal to extend the provisions in the UK Domestic Abuse Bill relating to extra-territorial jurisdiction to Northern Ireland by way of a Legislative Consent Motion.

## **8. Legislative Consent Motion - Sentencing (Pre-Consolidation Amendments) Bill**

The Committee considered the Legislative Consent Memorandum in respect of the Sentencing (Pre-Consolidation Amendments) Bill which the Department of Justice had laid in the Assembly on 27 April.

*Agreed:* The Committee agreed that it was content with the Department of Justice's proposal to extend provisions in the Sentencing (Pre-Consolidation Amendments) Bill relating to the transfer of community orders, youth rehabilitation orders and suspended sentence orders imposed by the courts in England and Wales to Northern Ireland by way of a Legislative Consent Motion.

*Agreed:* The Committee agreed that it was content to support the Minister of Justice in seeking the Assembly's endorsement of the Legislative Consent Motion:

*“That this Assembly endorses the principle of the extension of the relevant provisions of the Sentencing (Pre-Consolidation Amendments) Bill, introduced in the House of Lords on 21 January 2020, relating to the transfer of community orders, youth rehabilitation orders and suspended sentence orders imposed by the courts in England and Wales to Northern Ireland so far as these matters fall within the legislative competence of the Assembly.”*

## **9. Department of Justice Budget 2020-21 - Consideration of Committee Position**

The Committee considered further information and a draft response outlining the Committee's position in relation to the Department of Justice 2020-21 budget.

*Agreed:* The Committee agreed the response on the Department of Justice budget 2020-21 to be sent to the Committee for Finance, the Department of Justice and the Assembly Research Service.

*Agreed:* The Committee agreed to request a copy of the Permanent Secretary's response to the points raised in Mr Allister's correspondence to assist consideration of this matter.
