3. Matters Arising

<u>Items 1 to 6 - Notes of Informal Meetings with Individuals on the Domestic Abuse and Family Proceedings Bill</u>

The Committee noted the notes of six informal meetings with individuals held in September to discuss their experiences of domestic abuse to assist the Committee's consideration of the Domestic Abuse and Family Proceedings Bill. The Committee also noted additional information provided by a number of the individuals that had been included with the relevant meeting notes.

The Committee considered a request from a number of individuals to meet with the Committee to share their experiences of domestic abuse and parental alienation.

7. Counter-Terrorism (Sentencing and Release) Bill – Update

The Committee considered correspondence from the Minister of Justice advising that she had received a request from the UK Government to bring forward a Legislative Consent Motion to operationalise a number of provisions within the proposed Counter Terrorism and Sentencing Bill but had concluded that, given the differing views on this matter, there was insufficient support for either a limited Legislative Consent Motion or for a full Legislative Consent Motion. Given the deadline for a response to the UK Government was 9 October, she had therefore written indicating that it would not be possible to secure legislative consent from the NI Executive for the relevant provisions within the Bill.

The Committee discussed the matter and the Assembly Standing Orders relating to Legislative Consent Motions.

Agreed: The Committee agreed to seek confirmation from the Minister of

Justice that she intended to lay a memorandum before the Assembly explaining why a Legislative Consent Motion is not being sought in

accordance with Standing Order 42A(4).

Agreed: The Committee agreed to request information from the Secretary of

State for Northern Ireland regarding how he intended to take this

matter forward in the absence of a LCM.

Agreed: The Committee agreed to request advice on the options available to a

committee or an individual MLA in the absence of the Minister laying

a Memorandum.

8. Implementation of Domestic Homicide Reviews in Northern Ireland- Update

The Committee considered information from the Department of Justice providing an update on the implementation of Domestic Homicide Reviews (DHRs) in Northern Ireland.

Agreed: The Committee agreed to request clarification from the Department of

Justice on the rationale for not including death by suicide within the

scope of the DHR process at the outset.

9. CJINI Report – A Thematic Inspection of Public Protection Arrangements in Northern Ireland – Update on Implementation of Action Plan

The Committee considered an update from the Department of Justice on progress to deliver the action plan to address the four strategic recommendations and two operational recommendations in the Criminal Justice Inspection Report of the Public Protection Arrangements in Northern Ireland that was published in October 2019.

Agreed: The Committee agreed to request information from the Department of

Justice on progress in respect of the development of performance

indicators.

10. Stocktake of Policing Oversight and Accountability Arrangements

The Committee considered information provided by the Department of Justice on the first stage of the Stocktake of Policing Oversight and Accountability Arrangements which will involve targeted engagement with key bodies to identify key issues to be considered during the stocktake.

Agreed: The Committee agreed to schedule an oral evidence session with

departmental officials on the key issues to be considered during the

stocktake.

11. Penalty Notices for Disorder – Changes to Departmental Guidance

The Committee considered further information provided by the Department on the views of Victim Support Northern Ireland on the revision of the guidance in relation to penalty notices for disorder and the date from which the new thresholds would apply.

Agreed: The Committee agreed that it was content to note the changes to the

Department of Justice Guidance in relation to the Penalty Notice Scheme introduced in the Justice Act (Northern Ireland) 2011.

12. Correspondence

i. The Committee considered a letter from an individual on behalf of local activists and groups of Amnesty International outlining human rights abuses in Xinjiang region of China against Muslim ethnic minorities.

Agreed: The Committee agreed to respond to the individual indicating that this issue does not fall within the remit of the Committee for Justice.

ii. The Committee considered a memo from the Committee for Finance advising that it had written to all Executive Ministers requesting an overview of all bids submitted by each Department within the in-year monitoring process and bids supported by costed proposals for Covid-19 related funding outside the in-year monitoring process.

Agreed: The Committee agreed to ask the Department of Justice for a copy of

its response to the Committee for Finance.

iii. The Committee considered a Criminal Justice Inspection Northern Ireland report on 'How the Criminal Justice System Deals with Modern Slavery and Human Trafficking in Northern Ireland.'

Agreed: The Committee to request a copy of the response from the Department of Justice and justice bodies to the findings and recommendations in the inspection report.
