3. Committee Protocols

The Committee discussed a number of protocols and procedures covering arrangements for committee meetings, correspondence and requests for meetings not linked to its strategic priorities or statutory responsibilities, approaches to preparation for evidence sessions, outcomes of an effective committee, a Committee Induction Plan and the Committee use of social media.

Agreed: The Committee agreed that committee meetings would be held in public

Agreed: The Committee agreed an approach for dealing with correspondence and

requests for meetings not specifically linked to its strategic priorities or

statutory duties.

Agreed: The Committee agreed that further consideration would be given to scheduling

a questioning techniques session when the strategic priorities had been

decided.

4. Briefing by the Committee Clerk on Statutory Rules and the approach to be taken

The Committee Clerk outlined a proposed approach to manage, within the statutory time periods available, the backlog of Statutory Rules laid by the Department of Justice and the Attorney General for Northern Ireland since March 2017 that had been referred to the Committee to scrutinise.

Agreed: The Committee agreed the approach to be taken to consider the backlog of Statutory Rules laid by the Department of Justice and the Attorney General for

scrutinise.

Agreed: The attendance of the Attorney General for Northern Ireland at the meeting on

30 January to discuss the three Statutory Rules he had made would provide an

opportunity for a broader discussion on criminal justice issues.

Agreed: The Committee agreed that, the two oral overview briefings on the

Department of Justice should be recorded by Hansard.

6. Declaration of Members' Interests

The Chairperson advised Members that the relevant entry from the Members' Register of Interests for each Member of the Justice Committee had been circulated.

The Chairperson advised that 'proceedings of the Assembly' included meetings of the Committee for Justice and asked Members if they had any interests to declare.

Agreed: The Committee for Justice resolves under Standing Order 43 to delegate to the Examiner of Statutory Rules the technical scrutiny of Statutory Rules referred to the Committee under the above mentioned Standing Order.

The Committee further resolves that in carrying out this function the Examiner shall be authorised to report her technical findings on each Statutory Rule to

the Assembly and to the relevant Department, as well as to the Committee itself, and to publish her report.

The Committee noted the 2011-16 Justice Committee Legacy Report which set out its key activities, outputs and achievements.

11. Overview Briefing on the Department of Justice

Mr Peter May, Permanent Secretary of the Department of Justice, joined the meeting at 2.40 p.m.

Mr May provided an overview of the structure, responsibilities and budget of the Department of Justice.

The oral evidence was followed by a question and answer session.

Mr May agreed to provide further information on several issues.

The oral evidence session was reported by Hansard.

13. SR2016/431: The Victim Statement Regulations (Northern Ireland) 2016

The Committee considered SR2016/431: The Victim Statement Regulations (Northern Ireland) 2016 which provides for when, how and by whom the opportunity to make a

victim statement and supplementary victim statement is to be afforded in cases where the Director of Public Prosecutions has the conduct of criminal proceedings. Being afforded an opportunity to make a statement applies to a victim, bereaved family member and parent of a young victim.

Agreed: The Committee considered SR2016/431: The Victim Statement Regulations (Northern Ireland) 2016 and, subject to the Examiner of Statutory Rules' report, had no objection to the Rule.

14. SR2017/19: The County Court (Amendment) Rules (Northern Ireland) 2017

The Committee considered SR2017/19: The County Court (Amendment) Rules (Northern Ireland) 2017 which amends Appendix 2 of the County Court Rules (Northern Ireland) 1981 to update the scale costs payable to solicitors and barristers in proceedings in the County Court following a review carried out by the County Court Rules Committee.

Agreed: The Committee considered SR2017/19: The County Court (Amendment) Rules (Northern Ireland) 2017 and, subject to the Examiner of Statutory Rules' report, had no objection to the rule.

15. SR2017/26 The Police Pensions (Amendment) Regulations (Northern Ireland) 2017

The Committee considered SR2017/26 The Police Pensions (Amendment) Regulations (Northern Ireland) 2017 which makes a number of technical amendments to the Police Pensions Regulations (Northern Ireland) 2015 and the Royal Ulster Constabulary Pensions (Additional Voluntary Contributions) Regulations 1993 including a minor word change to remove any ambiguity, clarification of a legislative reference and addressing a minor drafting error identified by the Examiner of Statutory Rules.

Agreed: The Committee considered SR2017/26 The Police Pensions (Amendment) Regulations (Northern Ireland) 2017 and, subject to the Examiner of Statutory Rules' report, had no objection to the rule.

16. SR2017/27: The Costs Protection (Aarhus Convention) (Amendment) Regulations (Northern Ireland) 2017

The Committee considered SR2017/27: The Costs Protection (Aarhus Convention) (Amendment) Regulations (Northern Ireland) 2017 which amends the Costs Protection (Aarhus Convention) Regulations (Northern Ireland) 2013 to enhance the flexibility and clarity of the arrangements in relation to levels of costs protection, costs on appeal, eligibility for costs protection and interim injunctions.

Agreed: The Committee considered SR2017/27: The Costs Protection (Aarhus Convention) (Amendment) Regulations (Northern Ireland) 2017 and, subject to the Examiner of Statutory Rules' report, had no objection to the rule.

17. SR2017/36: The Police Service of Northern Ireland and Police Service of Northern Ireland Reserve (Injury Benefit) (Amendment) Regulations 2017

The Committee considered SR2017/36: The Police Service of Northern Ireland and Police Service of Northern Ireland Reserve (Injury Benefit) (Amendment) Regulations 2017, which amends the PSNI and PSNI Reserve (Injury Benefit) Regulations to reflect the replacement of Incapacity Benefit by Employment Support Allowance and enable PSNI Pensions Branch to deduct ESA from an injury on duty pension on a point forward basis ensuring recipients do not receive duplicate payments for the same injury.

Agreed: The Committee agreed to request an overview of the current position from the Department of Justice including the number of cases, the likely timeframe for investigations and what is being done regarding ensuring positive relationships between victims and the PSNI/PPS.
