# PUBLIC ACCOUNTS COMMITTEE EVIDENCE SESSION – REQUEST FOR ADDITIONAL EVIDENCE INFORMATION

Thank you for your letter of 9 November 2020 requesting the provision of additional evidence by way of follow-up to my recent correspondence.

The tables have been updated to include the information requested. In the case of my own Department, I can confirm there is a current Senior Business Owner in place, John Crosby, for the AccountNI and eHR contracts. The updated information is highlighted in red in the tables attached at **Annex A**.

In the case of the Department of Justice, the Department has withheld the names of their senior responsible Owners on the following grounds:

Given that PAC findings may be reported/published the names of DoJ SROs/contract owners have been withheld from this return for security and data protection reasons on the grounds that they are junior staff members of the Department of Justice. This information has therefore been withheld under s40(2) (Personal Information of third parties) and s38 (Health and Safety) of the FOI Act.

In relation to your question regarding the provision of NI Direct Strategic Partner annual project accounts, the NI Direct Strategic Partner, BT, has apologised for the delay in providing the annual project accounts for the financial years from 2015-16 through to 2019-20. However, the absence of regular reporting of the annual project accounts to the Department was also a symptom of poor contract management,

which has been addressed, as outlined in the evidence sessions, with a dedicated contract management team. The team have reviewed all of the project accounts to date and will be requesting the 2020-21 accounts as soon as the financial year completes.

BT has advised they have taken steps internally to ensure that any and all future obligations regarding project accounts are prepared and audited in line with the contract timescales. The contract management team are meeting with BT regularly to manage this process.

I hope this response covers the information you requested. Should you require anything further please get in touch.
