#### 4. Matters Arising

- **Decisions made under Standing Order 115(9)**

**Noted:** The Committee noted that, under temporary Standing Order 115(9), the Committee agreed, via correspondence on 6 May 2021, to follow the practice of its predecessors in terms of ensuring adequate disclosure during the complaints process.

- **Letter to All-Party Group (APG) on Congenital Heart Disease**

**Agreed:** Following a request from Mr Roy Beggs MLA, Vice Chairperson of the APG on Congenital Heart Disease, the Committee agreed to grant an extension to 30 June 2021 for a response from the APG on matters raised by the Committee in relation to the continued vacancy in the position of Chairperson of the Group.

- **Social Media Training for Members**

Members discussed the planned Member developments sessions on 'Protecting Your Social Media Reputation', which was being offered to all MLAs at the request of the Committee.

**Agreed:** The Committee agreed that Committee members will respond via their respective parties to this opportunity.

**Agreed:** The Committee agreed that the Committee Secretariat will enquire whether, in the event of the upcoming sessions being oversubscribed, further sessions could be offered in future.

### 5. Procedures for investigating complaints against Ministers – Assembly Legal Advice

Members received briefings from the Committee Secretariat and from Assembly Legal Services on this agenda item.

Members discussed draft amendments to the Assembly Members (Independent Financial Review and Standards) Act (Northern Ireland) 2011 (General Procedures) Direction 2016 ('the General Procedures Direction'). The purpose of the amendments would be to establish procedures for the Commissioner for Standards to follow when investigating complaints of alleged breaches of the Ministerial Code of Conduct which align with the procedures for the investigation of complaints of alleged breaches of the Assembly Members' Code of Conduct.

Member also discussed issues relating to the relevant date from which alleged misconduct by Ministers could be investigated by the Commissioner for Standards.

**Agreed:** The Committee agreed to defer its decision on the proposed amendments to the General Procedures Direction until the next Committee meeting, when it would also consider the options on the relevant date from which alleged misconduct by Ministers could be investigated by the Commissioner for Standards.

**Agreed:** The Committee agreed that the Clerk will write to the Department of Finance to enquire as to the purpose of the provision in the Main Estimates 2021-22 for £5K in respect of a 'Ministerial Panel exercising functions of future Commissioners of Ministerial Standards' and how this aligns with the provisions in section 5 of the Functioning of Government (Miscellaneous Provision) Act (Northern Ireland) 2021.

### 6. Commissioner's Annual Report 2020-21

Members received a briefing from the Commissioner for Standards, Dr Melissa McCullough, on this agenda item.

Members were advised that the annual report remains embargoed until the Commissioner publishes it on 27 May 2021.

**Agreed:** The Committee agreed to write to the Secretary of State, in light of the applicable provisions in clause 4 of the Northern Ireland (Ministers, Elections and Petitions of Concern) Bill introduced in the House of Commons on 12 May 2021, to highlight the issue raised in the Commissioner's Annual Report regarding the urgent need for clarity both on the scope of the Ministerial Code of Conduct and on where responsibility for guidance and review of the Ministerial Code of Conduct falls.
