Dear Shane

I can confirm a Senior Crown Counsel reviewed my reports in relation to complaints against both Steve Aiken OBE MLA and Jim Wells MLA, including consideration of all supporting materials.

After reviewing the materials, the QC stated my report was *“an excellent, well-reasoned report”*. Aside from a few typos and syntax relating to a sentence which he recommended I restate more clearly, he had no further suggestions for amendments or otherwise.

In relation to Article 10 in particular, the QC considered that my description of Article 10 was correct, and further stated that Article 10 *“gives leeway for robust expression in the political sphere but it is not absolute and your distinction between public servants being questioned and political opponents debating an issue is legitimate”*. He further went on to state that, *“Ultimately it’s a judgment call on whether questions/ remarks/ gestures remain within the protection of Art 10 or fall on wrong side of line... In my view your assessment is reasoned and reasonable.”*

I hope this is of help to the Committee.
