The Committee agreed to ask the Executive Office what plans they have to address this imbalance.

Agreed: The Committee agreed to invite the Public Appointments Commissioner to a future meeting to discuss the issue.

*Agreed:* The Committee agreed to write to other Committee Chairpersons to establish if there could be a collective approach to taking this issue forward.

Agreed: The committee agreed to action all other correspondence as outlined on the correspondence memo.

## 18. Forward Work Programme

The Committee noted the draft Forward Work Programme.
