**1. Apologies**

Apologies were recorded as above.

**2. Chairperson's Business**

**2.1 Area Planning**

The Chairperson indicated that the Department had informally advised that although a report has been compiled on the feedback from the consultation on primary school Area Planning (which concluded in June 2013), the relevant revised primary school Area Plans have not been produced. The Committee noted that the relevant revised plans are now not expected to be produced until after April 2014. The Committee also noted that the Department had suggested that the briefing arranged for 2 April 2014 on this subject should be rescheduled.

**Agreed:** The Committee agreed to write to the Department of Education indicating that it required a Departmental update on primary school Area Planning on 2 April 2014 in line with previous commitments. The Committee further agreed that the Department should arrange for its officials to be accompanied by other witnesses from the Education and Library Boards; the Council for Catholic Maintained Schools and the Area Planning Steering Group (as appropriate) who can give a full account of the progress of primary school Area Planning to-date including an explanation of the previous and current delays and who can also set out the way forward for this important process.

## **2.2 The Business of Education Report**

The Chairperson indicated that he had attended the launch of the Integrated Education Fund: The Business of Education report on Monday 24 March 2014.

**Agreed:** The Committee agreed to write to the Department of Education to seek its views on the IEF report.

## **2.3 Pushkin Trust / Ulster Bank**

The Chairperson indicated that two organisations: the Pushkin Trust and the Ulster Bank had sought the opportunity to brief the Committee on education issues.

**Agreed:** The Committee agreed to invite the Pushkin Trust and the Ulster Bank to brief the Committee on education issues at a future meeting.

## **2.4 Bright Start - Strategic Framework and Key Actions**

The Committee noted that the Committee for the Office of the First Minister and deputy First Minister was to receive a briefing on Wednesday 26 March 2014 from OFMdFM officials on the NI Executive's Programme for Affordable and Integrated Childcare - "Bright Start".

**Agreed:** The Committee agreed to write to the Committee for the Office of the First Minister and deputy First Minister requesting sight of the relevant information on "Bright Start".

## **2.5 Boards of Governors**

Members noted recent reports relating to Departmental appointments to a school Board of Governors (BoG).

**Agreed:** The Committee agreed to write to the Department of Education to request:

- clarification on its powers to remove and replace governors (and the chairperson of a BoG);
- explanation as to how it confirms that the appointee is committed to the ethos of a school;
- details of the protocol in the event that the existing governors are not willing to accept the proposed new appointee; and

- details of the extent to which these powers have been applied to schools in Northern Ireland in recent years.

### **3. Draft Minutes of previous meeting**

**Agreed:** The minutes of the meeting held on 19 March 2014 were agreed by the Committee.

### **4. Matters Arising**

#### **4.1 Inquiry into the Education and Training Inspectorate and the School Improvement Process**

The Committee noted a submission from an Associate Assessor to the Committee's Inquiry into the Education and Training Inspectorate and the School Improvement Process.

**Agreed:** The Committee agreed to add this submission to its Inquiry report, and to publish the information on the Committee's webpage along with the other Inquiry papers.

The Committee noted further correspondence from the Department of Education which clarified that ETI does not share draft school inspection reports with colleagues in the Department. However the Committee also noted that this response appears to contradict an answer given by the Department to AQW 26136/11-15.

**Agreed:** The Committee agreed to add this correspondence to its Inquiry report, and to publish the information on the Committee's webpage along with the other Inquiry papers. The Committee also agreed to write to the Department to request an explanation as to why the information appears to contradict the answer given to AQW 26136/11-15 in October 2013.

The Committee noted further confidential submissions to the Inquiry.

- highlighting also the importance and apparent absence of Continuing Professional Development opportunities for teachers which are designed to enhance teachers' confidence in the promotion of STEM;
- seeking clarification as to how science is incorporated into primary Initial Teacher Education programmes so as to improve confidence amongst primary teachers in the teaching of STEM subjects;
- seeking information as to whether the teaching materials provided by Earth Science Outreach are promoted by DE in schools; and
- seeking clarity on the Terms of Reference for the Education and Training Inspectorate review of "The World Around Us".

## **8. Science in the Revised Curriculum – Assembly Research Briefing**

James Stewart, Assembly Research Officer briefed the Committee on his research paper on "Science in the Revised Curriculum".

**Agreed:** The Committee agreed to request further information comparing science teaching time and the use of enquiry-based teaching in other jurisdictions. The Committee also agreed to seek further information on how teaching colleges recruit science specialists and how the teaching of science in the primary curriculum is being addressed by the teacher training colleges.
